### Organization of work of the session

#### Note by the Secretariat

1. The draft organization of work of the Commission for Social Development at its thirty-eighth session, which is contained in the annex to the present note, has been prepared, pursuant to relevant decisions of the General Assembly and the Economic and Social Council, in order to facilitate the consideration of agenda items within the time-frame available and in accordance with the conference services allocated to the Commission.
2. The draft is based on the provisional agenda adopted at the thirty-seventh session and approved by the Council in its decision 1999/259.
3. Within the eight working days allotted to the thirty-eighth session, time is reserved for: formal and informal consultations on contributions of the Commission to the overall review of the implementation of the outcome of the World Summit for Social Development; a presentation of a report by Mr. Bengt Lindqvist, the Commission's Special Rapporteur on Disability; discussion on issues related to the International Year of Older Persons, 1999; informal consultations on issues related to disability and ageing; and a dialogue segment with non-governmental organizations on their role in the Summit review and appraisal process.
4. The timetable contained in the annex should be considered tentative and indicative; if the Commission completes its consideration of an item ahead of schedule, it may wish to proceed immediately to the next item.
5. The Commission is scheduled to meet from Tuesday, 8 February, to Thursday, 17 February 2000. Arrangements have been made to hold morning and afternoon meetings during the session; morning meetings will be held from 10 a.m. to 1 p.m., and afternoon meetings from 3 p.m. to 6 p.m.
