**JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN  
THE REPUBLIC OF THE UNION OF MYANMAR AND THE REPUBLIC OF  
ARMENIA**

The Republic of the Union of Myanmar and the Republic of Armenia,

With the purpose to promote mutual understanding and strengthen the friendship and co-operation among their two countries;

On the basis of the principles and purposes of the Charter of the United Nations and international law;

Have decided to establish diplomatic relations at ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communiqué;

In witness thereof, the undersigned representatives, duly authorised by their respective Governments, have signed this Joint Communiqué in New York on January 31, 2013, in two duplicates, in Myanmar, Armenian and English languages, all three texts being equally authentic.
