

JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA
AND
THE PRINCIPALITY OF ANDORRA

The Democratic Socialist Republic of Sri Lanka and the Principality of Andorra, guided by mutual willingness to develop fraternal ties of friendship and cooperation in the political, economic, cultural and other fields, have decided to establish diplomatic relations as of the date of signing of this Joint Communiqué.

The Democratic Socialist Republic of Sri Lanka and the Principality of Andorra agreed to establish diplomatic relations in accordance with the Vienna Convention on Diplomatic Relations of 18 April 1961 and relevant principles and norms of the United Nations Charter and International Law.

The Democratic Socialist Republic of Sri Lanka and the Principality of Andorra are fully convinced that the establishment of diplomatic relations corresponds to the interests of, and to the furtherance of cooperation between, the two countries.

In witness whereof, the undersigned representatives, duly authorized, have signed this Joint Communiqué, in duplicate, in the English and Catalan languages, both texts being equally authentic.

RELATIU A L'ESTABLIMENT DE RELACIONS DIPLOMÀTIQUES

El Principat d'Andorra i la República Democràtica Socialista de Sri Lanka, guiats pel desig mutu de promoure lligams fraternals d'amistat i de cooperació en els àmbits polític, econòmic, cultural i altres, han decidit establir relacions diplomàtiques a partir de la data de signatura d'aquest comunicat conjunt.

El Principat d'Andorra i la República Democràtica Socialista de Sri Lanka acorden establir relacions diplomàtiques d'acord amb la Convenció de Viena sobre relacions diplomàtiques de 18 d'abril de 1961 i els principis i normes fonamentals de la Carta de les Nacions Unides i del dret internacional.

El Principat d'Andorra i la República Democràtica Socialista de Sri Lanka estan plenament convençuts que l'establiment de relacions diplomàtiques es correspon amb els interessos dels dos països i l'aprofundiment de la seva cooperació.

A aquest efecte, els representants sotassinats, degudament autoritzats, signen aquest comunicat conjunt en dos exemplars, en català i en anglès. Ambdós textos són igualment fefaents.
