## I. Introduction

1. The special procedures are mandated by the Human Rights Council to report to it on their activities (see annex).
2. In 2009, the sixteenth annual meeting of special rapporteurs, independent experts and chairs of working groups decided that a joint communications report would be prepared (A/HRC/12/47, paras 24-26), with this decision being reconfirmed by the seventeenth annual meeting in 2010. This was in order to avoid duplication, rationalize documentation, allow examination of cross cutting issues, and ensure that the content of communications and any follow-up would feed into the universal periodic review mechanism more effectively. Mandate holders decided that the report should contain summaries of communications and statistical information (A/HRC/15/44, para. 26-27).
3. The outcome of the review of the work and functioning of the Human Rights Council calls on the Office of the United Nations High Commissioner for Human Rights to maintain information on special procedures in a comprehensive and easily accessible manner and encourages the use of modern information technology to reduce the circulation of paper (resolution 16/21, annex, paras. 29 and 60).

## II. Communications sent and replies received

4. All communications and their replies are available through the special procedures communications website at <https://spcommreports.ohchr.org>. This includes short summaries of all allegations communicated to States or other entities. The communications sent and responses received are also accessible at the same location electronically in their entirety through hyperlinks.
5. The present report covers all urgent appeals, letters of allegation and other letters sent by special procedure mandate holders between 1 March and 31 May 2024 and replies received from 1 May until 31 July 2024. Communications sent before 1 March 2024 are reported in previous communications reports submitted to the Council and also made available on the dedicated website [www.ohchr.org/EN/HRBodies/SP/Pages/CommunicationsreportsSP.aspx](http://www.ohchr.org/EN/HRBodies/SP/Pages/CommunicationsreportsSP.aspx).
6. The report also includes replies received from 1 March until 31 July 2024 relating to communications sent by special procedure mandate holders before 1 March 2024. Some of these replies supplement information communicated earlier by the respective States or other entities.
7. The present report contains urgent appeals sent by the Working Group on Arbitrary Detention and the Working Group on Enforced or Involuntary Disappearances and joint urgent appeals sent by them with other mandates. It does not contain other types of communications issued by these mandates, which are processed according to their own distinctive procedures and are reported separately in the annual reports of these two working groups.
8. The names of some alleged victims have been redacted to protect their privacy and to prevent further victimization. Names of victims are mentioned only when the individual concerned or their direct family has expressly consented or requested to have his, her or their name in the public report. In the original communications, the full names of the alleged victims were provided to the Government concerned after obtaining their appropriate consent. Names of alleged perpetrators have systematically been redacted in State replies to preserve the presumption of innocence.
9. In total, 218 communications were sent during this reporting period to 74 countries and other non-State actors to which 93 replies were received from 38 countries and other actors as listed below:

10. During the period considered, 76 communications were also sent to ‘other actors’, for example businesses, international bodies, agencies and non-State actors to which 22 replies were received. For detailed information see sections III, IV and V below.

11. The communications concerned 248 alleged identified victims, of which 182 were male and 66.

12. In preparing the statistics included in the present report, uniform reporting periods have been used, reflecting all communications sent between 1 March and 31 May 2024 and responses received in relation to these communications up to 31 July 2024.
