**Report of Guatemala on the implementation of Security Council

The Government of the Republic of Guatemala, pursuant to Security Council resolutions [1718 \(2006\)](#), [1874 \(2009\)](#), [2087 \(2013\)](#), [2094 \(2013\)](#), [2270 \(2016\)](#), [2321 \(2016\)](#), [2356 \(2017\)](#), [2371 \(2017\)](#), [2375 \(2017\)](#) and, most recently, [2397 \(2017\)](#), has the honour to inform the Committee established pursuant to resolution [1718 \(2006\)](#) about the measures that the country has taken with a view to effectively implementing the relevant provisions of these resolutions concerning the Democratic People's Republic of Korea.

The Ministry of Foreign Affairs of the Republic of Guatemala has continued to inform the relevant national authorities regarding its obligations under Security Council resolution [1718 \(2006\)](#) and subsequent resolutions. In this regard, Guatemala has adopted the necessary national and international measures to ensure compliance with its obligations in this area.

To this end, the competent national authorities have carried out various measures to strengthen the sanctions regime, including financial measures, measures concerning the movement of people and goods, the transfer of training, advice, technological services and assistance, restrictions on maritime and air transport, and technical and scientific cooperation.

In addition to the efforts to effectively implement the provisions of Security Council resolutions concerning the Democratic People's Republic of Korea, the Government of Guatemala has consistently and publicly condemned in the strongest terms the nuclear and ballistic missile tests, including the intercontinental-range tests, conducted by the Democratic People's Republic of Korea in flagrant violation of Council resolutions.

The Republic of Guatemala has joined other Member States in associating itself with the condemnations issued by the Security Council at its various meetings. The Ministry of Foreign Affairs has also issued more than 10 press releases this year condemning the missile tests and launches.
