SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF  
WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE  
REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The list of items of which the Security Council is seized is contained in documents S/1999/25 of 15 January 1999, S/1999/25/Add.2 of 29 January 1999, S/1999/25/Add.5 of 19 February 1999, S/1999/25/Add.11 of 1 April 1999, S/1999/25/Add.17 of 14 May 1999, S/1999/25/Add.22 of 18 June 1999, S/1999/25/Add.29 of 6 August 1999, S/1999/25/Add.37 of 1 October 1999, S/1999/25/Add.43 of 12 November 1999 and S/1999/25/Add.47 of 10 December 1999.

During the week ending 1 January 2000, the Security Council took action on the following item:

Security Council resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) (see S/1999/25/Add.43; see also S/1998/44/Add.13, 34, 38 and 42; and S/1999/25/Add.2, 18 and 22)

The Security Council resumed its consideration of the item at its 4086th meeting, held in private on 30 December 1999 in accordance with the understanding reached in its prior consultations.

In accordance with rule 55 of the provisional rules of procedure of the Security Council, the following communiqué was issued by the Secretary-General in place of a verbatim record:

"At its 4086th meeting, held in private on 30 December 1999, the Security Council considered the item entitled 'Security Council resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999)'. The representatives of Austria, Bangladesh, Belarus, Belgium, Bulgaria, Croatia, Cuba, the Czech Republic, Denmark, Egypt, Finland, Germany, Greece, Hungary, Italy, Luxembourg, Norway, Pakistan, Poland, Romania, Singapore, Slovakia, South Africa, Spain, Sweden, the former Yugoslav

Republic of Macedonia, Turkey and Ukraine were invited, at their request, to participate in accordance with rule 37 of the Council's provisional rules of procedure.

"Mr. Vladislav Jovanovic was invited, at his request, to be seated at the Council table during the discussion.

"The Permanent Observer of the Holy See to the United Nations was also invited, at his request, in accordance with the understanding reached in the Council's prior consultations, to participate without the right to vote.

"The Security Council heard a briefing under rule 39 of its provisional rules of procedure by Mr. Hédi Annabi, Assistant Secretary-General for Peacekeeping Operations.

"The members of the Council made comments and posed questions in connection with the briefing. Mr. Annabi responded to the comments and questions posed by members of the Council."
