**JOINT COMMUNIQUÉ ON THE ESTABLISHMENT OF DIPLOMATIC
RELATIONS BETWEEN THE KINGDOM OF LESOTHO AND THE PLURINATIONAL STATE OF BOLIVIA**

The Government of the Kingdom of Lesotho and the Government of the Plurinational State of Bolivia,

Desirous to reinforce and develop mutually beneficial relations between their countries and their peoples, in accordance with the objectives of the Charter of the United Nations,

Have decided to establish diplomatic and consular relations at Ambassadorial level between the Kingdom of Lesotho and the Plurinational State of Bolivia as of 08 November, 2024.

Have equally agreed that the provisions of the Vienna Convention of 18 April 1961 on Diplomatic Relations and of the Vienna Convention of 24 April 1963 on Consular Relations, will apply to the diplomatic and consular relations between Plurinational State of Bolivia and the Kingdom of Lesotho.

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed the present Joint Communiqué in New York, on 08 November 2024, in two originals each in English and Spanish languages, all texts being equally authentic. In case of divergence in interpretation of the Joint Communiqué, the English text shall prevail.

Deseosos de promover el entendimiento mutuo y fortalecer la amistad y la cooperación entre sus pueblos;

Guiándose por los propósitos y principios de la Carta de las Naciones Unidas y el derecho internacional, en particular en lo que respecta al respeto de la promoción de la paz y la seguridad internacionales, la igualdad entre los Estados, la soberanía nacional, la independencia, los tratados internacionales, la integridad territorial y la no injerencia en los asuntos internos de otros Estados,

Han decidido establecer relaciones diplomáticas, a partir de la fecha de la firma del presente Comunicado Conjunto;

Tienen la intención de que sus relaciones diplomáticas se basen en las disposiciones de la Convención de Viena sobre Relaciones Diplomáticas del 18 de abril de 1961;

En fe de ello, Sus Excelencias, los Embajadores Extraordinarios y Plenipotenciarios, debidamente autorizados por sus respectivos Gobiernos, han firmado en Nueva York el 08 de noviembre de 2024 el presente Comunicado Conjunto en español e inglés, siendo los tres textos igualmente auténticos y en caso de divergencia en la interpretación de este Comunicado, prevalecerá el texto en inglés.
