

Addendum

V. General provisions

- 1. At its 11th to 14th meetings, on 6 and 7 June 2022, the Ad Hoc Committee considered agenda item 5, entitled "General provisions".
- 2. For its consideration of item 5, the Ad Hoc Committee had before it the following:
- (a) Compilation of proposals and contributions submitted by Member States on the provisions on criminalization, the general provisions and the provisions on procedural measures and law enforcement of a comprehensive international convention on countering the use of information and communications technologies for criminal purposes (A/AC.291/9/Add.1 and A/AC.291/9/Add.3);
- (b) Overview of existing instruments, recommendations and other documents on countering the use of information and communications technologies for criminal purposes (A/AC.291/CRP.10);
- (c) Compilation of draft provisions submitted by Member States on criminalization, general provisions and procedural measures and law enforcement (A/AC.291/CRP.11).
- 3. Statements were made by representatives of the following Member States: Jamaica (on behalf of the Caribbean Community), Philippines, Switzerland, Russian Federation, Netherlands, Czechia, Azerbaijan, Canada, China, Thailand, Japan, Indonesia, Mexico, Liechtenstein, United States of America, Chile, United Kingdom of Great Britain and Northern Ireland, Malaysia, Argentina, Egypt, Singapore, Paraguay, Republic of Korea, Germany, France, Colombia, Pakistan, Ghana, Cuba, Iraq, New Zealand, South Africa, Portugal, Islamic Republic of Iran, Bolivarian Republic of Venezuela, Senegal, Australia, Slovenia, Nigeria, Brazil, Angola, Israel, Poland, Italy, Ecuador, Haiti, Burkina Faso, Eritrea, India, Dominican Republic,







Oman, Jordan, Peru, Costa Rica, Uruguay, Guatemala, Viet Nam, Belarus, Honduras, Zimbabwe, Morocco, Kenya, Armenia, Fiji, Saudi Arabia, Sudan and El Salvador.

- 4. The representative of the European Union, in its capacity as observer, made a statement on behalf of the European Union and its member States.
- 5. The Chair opened the floor for remarks of a general nature on proposals relating to the chapter containing general provisions, as well as on the questions on that chapter that had been prepared by the Chair on the basis of the submissions of Member States and shared in advance to guide a focused and structured discussion. Those remarks would be taken into consideration by the Chair in preparing, with the support of the Secretariat, a consolidated negotiating document in advance of the fourth session of the Ad Hoc Committee.
