ANNOTATIONS

Introduction

- 1. The provisional agenda for the fourth session of the Committee for Trade, Industry and Enterprise Development has been drawn up by the secretariat in consultation with the Bureau on the basis of the decisions and programme of work adopted by the Committee at its third session held in June 1999.
- 2. The provisional timetable has been proposed by the Bureau. The afternoon session of Friday, 23 June will approve the draft report of the fourth session.
- 3. At its third session, the Committee decided to hold its year 2000 Forum on "Electronic Commerce for Transition Economies in the Digital Age". A preliminary agenda for this event can be found in annex I. The first two days of the Committee session will be dedicated to the Forum and the subsequent two and a half days to the regular session:

- 4. The fourth Committee session will, therefore, formally begin at 10:00 on Wednesday, 21 June 2000.
- 5. It should be recalled that to enter the Palais des Nations delegates must obtain security badges at the Villa Les Feuillantines, which is located near the Palais gate at the Place des Nations (see annex II). By registering in advance, delegates will find their badges already prepared for them at the Villa. The registration form can be found in annex II.

EXPLANATORY NOTES

Item 1 - Adoption of the agenda

6. In accordance with the Commission's rules of procedure, the first item on the provisional agenda is the adoption of the agenda (ECE/TRADE/250).

Item 2 - Election of officers

7. At its third session, the Committee elected Mr. M. Vilchez-Barros (Spain) Chairman, and Messrs. G. Fehér (Hungary) and Y. Beletsky (Russian Federation) its vice-chairmen.

<u>Item 3 - Matters arising from the fifty-fifth session of the Economic Commission for Europe</u>

8. The secretariat will report orally on the discussions held at and the decisions adopted by the Commission at its fifty-fifth session, to be held in May 2000. If necessary, extracts from the report of that session will be made available as a conference room paper. As requested by the Committee at its third session, the latter will find before it a note by the Bureau (TRADE/2000/1) identifying activities of the subsidiary bodies which could contribute to recovery in the Balkan region.

<u>Item 4 - Trade analysis: review of recent and prospective trade trends,</u> policies and problems, including matters arising from the year 2000 Forum

(a) Review of recent and prospective trade trends, policies and problems

- 9. The secretariat will present its "Trade Policy Review" paper (TRADE/2000/2) for comment and discussion. As agreed at the previous session of the Committee, the paper will survey the activities of international organizations to promote foreign direct investment in transition economies.
- 10. The secretariat will introduce the latest edition of the <u>Economic Survey of Europe</u>, which reviews current economic developments in the ECE region.

A short presentation will be given on the special section in the $\underline{\text{Economic}}$ $\underline{\text{Survey of Europe}}$ which reviews various aspects of 10 years of reform in transition economies

(b) Matters arising from the 2000 Forum

11. Under this agenda item, the Chairman of the Forum on Electronic Commerce for Transition Economies in the Digital Age to be held on 19 and 20 June will report on the discussions held and the conclusions drawn by the Forum. The Committee will also have before it the Proceedings of the 1999 Round Table on the Polish Experience of Transition (ECE/TRADE/251).

(c) Review of major aspects of multilateral trade negotiations of special interest to transition economies

- 12. The Committee will have before it a note by the secretariat on the major aspects of multilateral trade negotiations of special interest to transition economies (TRADE/2000/3).
- 13. Delegations are welcome to present brief reports on relevant developments and problems in their countries. If such reports are made available sufficiently in advance (i.e. at least two weeks before the meeting), they will be reproduced by the secretariat. Reports may be submitted by regular post or by e-mail to CTIED@unece.org

<u> Item 5 - Trade Facilitation</u>

- 14. The Committee will have before it a note by the secretariat on progress achieved and suggestions for closer linkages between the United Nations Centre for the Facilitation of Procedures and Practices in Administration, Commerce and Transport (UN/CEFACT) and other subsidiary bodies (TRADE/2000/4) and the report of the sixth session of UN/CEFACT (TRADE/CEFACT/2000/..).
- 15. The secretariat will present a report on cooperation between the United Nations Regional Economic Commissions in the area of trade facilitation (TRADE/2000/17).

Item 6 - Agricultural quality standards

16. The Committee will have before it the report of the eleventh session of the Working Party on Standardization of Perishable Produce and Quality Development (WP.7) (TRADE/WP.7/1999/7) and a note by the secretariat (TRADE/2000/5) summarizing progress achieved.

Item 7 - Standardization Policies

17. The Committee will have before it the report of the ninth session of the Working Party on Technical Harmonization and Standardization Policies (WP.6) (TRADE/WP.6/1999/18) and a note by the secretariat (TRADE/2000/6) summarizing progress achieved and containing suggestions for closer linkages between the Working Party and other subsidiary bodies.

Item 8 - Trade and investment promotion

- 18. The Committee will have before it the report of the forty-eighth session of the Working Party on International Legal and Commercial Practice (WP.5)(TRADE/WP.5/1999/13) and a note by the secretariat (TRADE/2000/7) summarizing progress achieved. Also before the Committee will be the final report of the November 1999 WP.5 Forum on New Competition Laws and Their Implications for Business in Central and Eastern Europe (TRADE/WP.5/1999/4).
- 19. The Chairman of the Advisory Group on Arbitration of the Working Party on International Legal and Commercial Practice and the secretariat will report orally on progress being made on the revision of the European Convention on International Commercial Arbitration.

Item 9 - Industry and enterprise development

(a) Cross-sectoral enterprise development activities

20. The Committee will have before it a note by the Bureau (TRADE/2000/8) on the strategic directions of the cross-sectoral programme of work, including the future of sector-specific activities. The Committee is required to make a decision about future work on the basis of the 1997 Plan of Action (E/ECE/1347).

A presentation will be made on the strategic directions of the UN/ECE's crosssectoral enterprise development activities

(b) <u>Development of small and medium-sized enterprises</u>

21. Under this sub-item, the Committee will have before it a report on the activities of the secretariat in this area (TRADE/2000/9).

(c) <u>Enterprise development activities with an emphasis on</u> the chemical industry

22. The ad hoc Group of Experts on the Chemical Industry will submit the report of its third session (TRADE/CHEM/GE.1/2000/9).

(d) <u>Enterprise development activities with an emphasis on the steel</u> industry

23. The ad hoc Group of Experts on Steel will submit the report of its third session (TRADE/STEEL/GE.1/2000/6).

<u>Item 10 - Liaison with other organizations, and the organization of seminars</u> and workshops

24. Under this sub-item, the Committee will have before it a report on the activities of the secretariat in these areas (TRADE/2000/10).

Item 11 - Extrabudgetary activities in support of the work programme

25. The Committee will have before it a note by the Bureau and the secretariat (TRADE/2000/11) concerning operational activities of the Committee's subsidiary bodies, identifying needs and financing for them. It will also have before it a report by the secretariat on recent developments in extrabudgetary activities in support of the work programme and, in particular, the work in countries in transition (TRADE/2000/12).

A presentation will be made of one extrabudgetary project

<u>Item 12 - Regional advisory activities with special presentations on SECI and the OSCE Economic Forum</u>

26. The Committee will have before it a report by the secretariat on recent developments in the regional advisory activities in support of the countries in transition (TRADE/2000/13).

The Regional Adviser on Trade Facilitation will make a presentation on the UN/ECE activities supporting the Southeast European Cooperative Initiative (SECI)

The Regional Adviser on Trade and Investment Promotion will make a presentation on the OSCE Economic Forum

27. The secretariat will also report on the progress achieved so far in establishing a roster of experts for UN/ECE regional advisory activities.

Item 13 - Activities of the Commission's other principal subsidiary bodies

28. The Committee will have before it a paper by the secretariat on trade and investment related activities of other principal subsidiary bodies (TRADE/2000/14).

Item 14 - Programme of Work, 2000-2002

29. The Committee will have before it a draft programme of work (TRADE/2000/15) prepared by the secretariat taking into account the proposals made by the Bureau on the reviewed priorities (ECE/TRADE/1372). Should the decisions taken by the Commission at its fifty-fifth session require amendments to the draft programme of work, a conference room paper will be prepared indicating such changes.

<u>Item 15 - Other business</u>

(a) Role and strategic direction of the Committee

30. The Committee will have before it a note by the Bureau (TRADE/2000/16) containing ideas on the role and strategic direction of the Committee.

(b) Dates of the next session and theme of the Forum

- 31. The secretariat notes that the dates of the fifth session of the Committee are provisionally set for 12-15 June 2001 and that the Committee is expected to agree on a theme for the 2001 Committee forum or round table. Three alternative topics have been proposed:
 - (i) <u>Experiences of New Transition Economy Members in the World Trade</u>
 Organization (WTO)
 - (ii) <u>The Role of the Service Sector in Trade, Investment and</u> <u>Enterprise Development in Transition Economies</u>
 - (iii) The Role of the Committee for Trade, Industry and Enterprise

 Development (CTIED) in Trade Policy.

Item 16 - Adoption of the report

32. In accordance with established practice, the Committee will adopt its report on the basis of a draft prepared by the secretariat.


