تقرير اللجنة الفرعية لتعزيز وحماية حقوق الإنسان:

(ب) انتخاب الأعضاء

مذكرة من الأمين العام

١- طبقاً لقراري المجلس الاقتصادي والاجتماعي ١٣٣٤(د-٤٤) المؤرخ في ٣١ أيار/مايو ١٩٦٨ و ٣٥/١٩٨٦ المؤرخ في ٢٣ أيار/مايو ١٩٨٦، ومقرريه ٢١/١٩٧٨ المؤرخ في ٥ أيار/مايو ١٩٧٨ و ١٠٢/١٩٨٧ المؤرخ في ٦ شباط/فبراير ١٩٨٧، انتخبت لجنة حقوق الإنسان في دورتها الرابعة والأربعين، باقتراح سري، ٢٦ عضواً في اللجنة الفرعية لمنع التمييز وحماية الأقليات (التي أعيدت تسميتها في عام ١٩٩٩ باسم اللجنة الفرعية لتعزيز وحماية حقوق الإنسان) من بين الخبراء الذين رشحتهم الدول الأعضاء في الأمم المتحدة على النحو التالي: (أ) سبعة أعضاء من الدول الأفريقية؛ (ب) خمسة أعضاء من الدول الآسيوية؛ (ج) ثلاثة أعضاء من دول أوروبا الشرقية؛ (د) خمسة أعضاء من دول أمريكا اللاتينية؛ (هـ) ستة أعضاء من دول أوروبا الغربية ودول أخرى.

* يصدر المرفق الأول بهذه الوثيقة، نظراً لطوله، باللغات الأصلية فقط، إذ لا تتوفر لشعبة خدمات المؤتمرات التابعة لمكتب الأمم المتحدة في جنيف القدرة الكافية على ترجمة الوثائق التي تتجاوز، إلى حد كبير، حد ٣٢ صفحة الذي أوصت به الجمعية العامة (انظر قرار اللجنة ٩٤/١٩٩٣، الفقرة ١).

٢- ووفقاً لقرار المجلس ٣٥/١٩٨٦، ينتخب أعضاء اللجنة الفرعية لفترة أربع سنوات، وينتخب نصف أعضاء اللجنة الفرعية والعدد المقابل من المناوبين، إن وجد، مرة كل عامين. وقام رئيس الدورة الرابعة والأربعين للجنة حقوق الإنسان بإجراء القرعة لانتخاب الأعضاء، وعند الاقتضاء، العدد المناظر من المناوبين الذين ستنتهي فترة ولايتهم بعد عامين وفقاً للنمط التالي: ثلاثة أعضاء من الدول الأفريقية؛ وثلاثة أعضاء من الدول الآسيوية؛ وعضو واحد من دول أوروبا الشرقية؛ وثلاثة أعضاء من دول أمريكا اللاتينية؛ وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

٣- وفي الأعوام ١٩٩٠ و ١٩٩٢ و ١٩٩٤ و ١٩٩٦ و ١٩٩٨، عندما انتهت فترة ولاية نصف أعضاء اللجنة الفرعية، أجرت لجنة حقوق الإنسان في دوراتها السادسة والأربعين والثامنة والأربعين والخمسين والثانية والخمسين والرابعة والخمسين انتخابات جديدة لأعضاء اللجنة الفرعية ومناوبيهم^(١).

٤- ويتضمن المرفق الثاني قائمة بأسماء الأعضاء الحاليين في اللجنة الفرعية.

٥- ولما كانت مدة ولاية نصف أعضاء اللجنة الفرعية قد انقضت مرة أخرى، فإن لجنة حقوق الإنسان مدعوة في دورتها السادسة والخمسين لإجراء انتخاب جديد لأعضاء اللجنة الفرعية والمناوبين وفقاً للنمط التالي: أربعة أعضاء من الدول الأفريقية؛ وعضوان من الدول الآسيوية؛ وعضوان من دول أوروبا الشرقية؛ وعضوان من دول أمريكا اللاتينية؛ وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

٦- وأكدت لجنة حقوق الإنسان من جديد، في قرارها ٨١/١٩٩٩ المؤرخ في ٢٨ نيسان/أبريل ١٩٩٩، طلبها من الدول أن ترشح للعمل كأعضاء ومناوبين في اللجنة الفرعية خبراء مستقلين ممن يشهد لهم بالكفاءة في ميدان حقوق الإنسان. وأن تحترم بالكامل استقلال الأعضاء والمناوبين. وطلبت اللجنة أيضاً إلى الدول التي تسمي مرشحين للجنة الفرعية تقديم ترشيحات في وقت مبكر بقدر كاف لتمكين أعضاء لجنة حقوق الإنسان من أن يقيموا بدقة مؤهلات المرشحين واستقلالهم. وتجدر الإشارة إلى أن اللجنة الفرعية كانت قد استرعت انتباه لجنة حقوق الإنسان بوجه خاص، في قرارها ٣٢/١٩٨٧، إلى توصية الفريق العامل المعني بأشكال الرق المعاصرة بأن تحاول لجنة حقوق الإنسان إقناع جميع الحكومات بترشيح مزيد من النساء لانتخابهن في اللجنة الفرعية.

- ٧- وفيما يتعلق بتسمية المناوبين، اعتمد المجلس الاقتصادي والاجتماعي القرار ٣٢/١٩٨٣ الذي قرر فيه أنه:
- بصرف النظر عن الفقرة ٢ من المادة ١٣ من النظام الداخلي للجان الفنية للمجلس الاقتصادي والاجتماعي، تسري القواعد التالية من الآن فصاعداً على اللجنة الفرعية لمنع التمييز وحماية الأقليات:
- (أ) يجوز أن تصحب تسمية المرشح لعضوية اللجنة الفرعية تسمية خبير من نفس الجنسية ينتخب في آن واحد مع المرشح للعضوية ويمكن أن يعمل مؤقتاً بصفة مناوب له في حالة عدم تمكن العضو من الحضور؛
- (ب) تكون المؤهلات المطلوب توفرها في الأعضاء المناوبين هي نفسها المطلوب أن تتوفر في الأعضاء؛
- (ج) لا يجوز لأي شخص غير الخبير المنتخب كعضو مناوب أن يعمل كعضو مناوب لأحد الأعضاء، عملاً بالفقرة الفرعية (أ) أعلاه.
- ٨- وحتى ١٥ تشرين الثاني/نوفمبر ١٩٩٩ تلقى الأمين العام ترشيحات لانتخاب أعضاء اللجنة الفرعية من حكومات إثيوبيا وأرمينيا وباراغواي وبيرو وبيلاروس وتونس وجمهورية كوريا ورومانيا والسودان وغواتيمالا وكوبا ولبنان ومصر المغرب والنرويج ونيبال وهولندا والولايات المتحدة الأمريكية واليابان.
- ٩- وستعم الرسائل والترشيحات الأخرى التي ترد من الحكومات كإضافات إلى هذه الوثيقة.
- ١٠- وترد أدناه قائمة بالترشيحات التي وردت من الحكومات حتى الآن، ويتضمن المرفق الأول بيانات السير ذاتية للمرشحين.

Annex I

BIOGRAPHICAL DATA

Mr. MOUNIR ZAHRAN (Expert)

(Nominated by the Government of Egypt)

Dr. Mounir ZAHRAN was born and raised in Cairo, Egypt, in 1935. He studied at the University of Cairo: Licence cum Laude in 1956, Political Economy Diploma in 1958 and Applied Economics Diploma in 1959 from same University. Later, Dr. ZAHRAN received a Diploma in Public Law in 1963 and a Ph.D. in International Law in 1966 from the University of Paris.

Dr. ZAHRAN was a practising attorney-at-law in Cairo from 1956 to 1958, then joined the Egyptian Diplomatic Corps in 1958. In the Ministry of Foreign Affairs Headquarters, he served in the Research, Economic and International Organizations Departments. He was also Chief, United Nations Technical Assistance Coordinating DPT from 1968 to 1969. He served as adviser to the Former Deputy Prime Minister and Minister for Foreign Affairs; as Deputy Director of the Economic Affairs Department in 1983-1984; as Special Envoy of the President of Egypt in the mediation between Senegal and Mauritania in 1989-1990; and as Director of the Department of International Organizations in 1990-1991.

In Egyptian diplomatic missions abroad, Dr. ZAHRAN served in the Egyptian Embassies in Paris, Brussels, Luxembourg and Washington D.C. He previously served as member of the Egyptian Permanent Mission to the United Nations in New York, the Egyptian Mission to the European Communities in Brussels and Ambassador to the Kingdom of Morocco. From August 1991 until July 1999 he was Permanent Representative of Egypt to the European Office of the United Nations and International Organizations having their seats in Geneva.

His experience with international organizations, meetings and conferences started with his participation in the Ministerial Preparatory Meeting of the First Non-Aligned Conference of Heads of State or Government held in Cairo in 1961. He attended the 14th UNESCO General Conference in Paris in 1966. In 1968, Dr. ZAHRAN was selected by the United Nations to participate in a group of 15 representatives from the developing countries to study the major problems of United Nations and specialized agency technical assistance programmes implemented in favour of the developing countries. At the United Nations in New York, he represented Egypt in several sessions of the United Nations General Assembly, in particular in the First, First Special and Second Committees. He represented Egypt also on the Outer Space and Sea-Bed Committees. At Geneva, he represented Egypt at the Conference on Disarmament, GATT, WTO, UNCTAD, specialized agencies and other international organizations.

Dr. ZAHRAN represented Egypt at the INTELSAT Plenipotentiary Conference, Washington D.C., 1969-1971, the ICEC (NORTH/SOUTH), Paris, 1975-1977, the Euro-Arab Dialogue Meetings at the Arab League Headquarters in Cairo and some of its meetings in Brussels: EEC/EGYPT Cooperation Council Meetings in Luxembourg in 1980 and 1984 and in Brussels in 1982, several Arab Summit Conferences, Islamic Conference Summit, Arab League

Council of Foreign Ministers, Islamic Conferences of Foreign Ministers and several Ministerial Meetings of the Organization of African Unity. He attended and/or elected chairman of several meetings of the Conference on Disarmament, GATT, WTO, ICAO, WIPO, IMF and IBRD, ECA, ESCWA, CAFRAD, MULPOC, AATPO, ICTP, GSTP, UNCTAD, the ILO Board and others.
