

I. Introduction

1. At its 2nd plenary meeting, on 13 September 2024, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-ninth session, the item entitled:

"Promotion and protection of human rights:

- (a) Implementation of human rights instruments;
- (b) Human rights questions, including alternative approaches for improving the effective enjoyment of human rights and fundamental freedoms;
- (c) Human rights situations and reports of special rapporteurs and representatives;
- (d) Comprehensive implementation of and follow-up to the Vienna Declaration and Programme of Action"

and to allocate it to the Third Committee.

2. The Committee considered the item jointly with its sub-items, heard introductory statements and held interactive dialogues and a general discussion at its 16th to 40th meetings from 16 to 30 October and on 1 and 4 November 2024. An account of the Committee's discussion under the item is contained in the relevant summary records. An account of the Committee's consideration of the sub-items is contained in the addenda to the present report.
