

Letter dated 27 December 2024 from the Permanent Representative of Switzerland to the United Nations addressed to the President of the Security Council

As part of Switzerland's commitment to the implementation of the women and peace and security agenda, and in connection with a letter to the President of the Security Council dated 30 June 2023 (S/2023/493), I am pleased to refer to the statements of 11 women who, in their capacity as representatives of civil society organizations, gave briefings to the Security Council during Switzerland's presidency of the Council for the month of October 2024 (see annex).

Those 11 civil society representatives briefed the Security Council in connection with the items entitled:

- The situation in Somalia (3 October)
- The situation in the Great Lakes region (8 October)
- The situation in Libya (9 October)
- The situation in the Middle East (Yemen) (15 October)
- Identical letters dated 19 January 2016 from the Permanent Representative of Colombia to the United Nations addressed to the Secretary-General and the President of the Security Council (S/2016/53) (15 October)
- The question concerning Haiti (22 October)
- The situation in the Middle East (Syrian Arab Republic) (23 October)
- Women and peace and security (24 October)
- Reports of the Secretary-General on the Sudan and South Sudan (28 October)

As a country with a long-standing engagement on women and peace and security, and as a signatory to the statement of shared commitments on women and peace and security, Switzerland will continue to engage with civil society representatives on matters relating to the work of the Security Council and pay close attention to the issues raised and recommendations made during their briefings. I trust that the statements will serve as a useful basis for Council members in their future work and discussions, beyond Switzerland's current mandate as an elected member of the Security Council.
