Review of the implementation of General Assembly resolutions [48/218 B](#), [54/244](#), [59/272](#), [64/263](#), [69/253](#) and [74/257](#)

Report of the Fifth Committee

I. Introduction

1. At its 2nd plenary meeting, on 13 September 2024, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-ninth session the item entitled “Review of the implementation of General Assembly resolutions [48/218 B](#), [54/244](#), [59/272](#), [64/263](#), [69/253](#) and [74/257](#)” and to allocate it to the Fifth Committee.
2. The Fifth Committee considered the item at its 30th meeting, on 28 March 2025. Statements and observations made in the course of the Committee’s consideration of the item are reflected in the relevant summary record.¹

II. Consideration of draft resolution [A/C.5/79/L.30](#)

3. At its 30th meeting, on 28 March, the Committee had before it a draft resolution entitled “Review of the implementation of General Assembly resolutions [48/218 B](#), [54/244](#), [59/272](#), [64/263](#), [69/253](#) and [74/257](#)” ([A/C.5/79/L.30](#)), submitted by the Chair of the Committee on the basis of informal consultations coordinated by the representative of Sweden.
4. At the same meeting, the Committee adopted draft resolution [A/C.5/79/L.30](#) without a vote (see para. 5).

III. Recommendation of the Fifth Committee

5. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

Review of the implementation of General Assembly resolutions 48/218 B, 54/244, 59/272, 64/263, 69/253 and 74/257

The General Assembly,

Recalling its resolutions 48/218 B of 29 July 1994, 54/244 of 23 December 1999, 59/272 of 23 December 2004, 64/263 of 29 March 2010, 69/253 of 29 December 2014 and 74/257 of 27 December 2019,

Recalling also its resolution 61/275 of 29 June 2007,

1. *Reiterates* the five-year non-renewable term of the Under-Secretary-General for Internal Oversight Services, and requests the Secretary-General to continue to ensure the full implementation of resolution 48/218 B in future appointments;

2. *Decides* to evaluate and review at its eighty-fourth session the functions and reporting procedures of the Office of Internal Oversight Services and any other matter which it deems appropriate, and to that end to include in the provisional agenda of that session an item entitled “Review of the implementation of General Assembly resolutions 48/218 B, 54/244, 59/272, 64/263, 69/253, 74/257 and 79/___”.
