

## Letter dated 1 April 2025 from the Permanent Representative of the Russian Federation to the United Nations addressed to the Secretary-General, the President of the General Assembly and the President of the Security Council

I would like to draw your attention to the continued strikes by the Armed Forces of Ukraine against the energy infrastructure of the Russian Federation in violation of the moratorium on such strikes that came into force on 18 March 2025 (see annex).

We consider such attacks to be terrorist acts, convincingly proving that having orally agreed to the "energy ceasefire", promoted by the United States, the Kiev regime is not interested in any peace agreements and continues to plan and carry out strikes against Russia's energy infrastructure.

The Russian Federation has been fully and strictly adhering to the moratorium since 18 March, but nonetheless reserves the right to respond, including by withdrawing from the oral agreement, should the Kiev regime proceed with its destructive course and continue non-compliance with the moratorium.

We call on all responsible Governments and international organizations, including the United Nations, to resolutely condemn these strikes and publicly distance themselves from the Kiev regime.

I would be grateful if the present communication and its annex could be circulated as a document of the General Assembly, under agenda items 32 (a) and 110, and of the Security Council.
