Note by the Secretariat

1. Since 2016, the Secretariat has prepared a synthesis of voluntary submissions by functional commissions of the Economic and Social Council and other intergovernmental bodies and forums, made in response to an invitation by the President of the Council and in line with the call in paragraph 85 of the 2030 Agenda for Sustainable Development (General Assembly resolution [70/1](#)) for thematic reviews of progress on the Sustainable Development Goals to be held at the high-level political forum on sustainable development, to be supported by reviews by the functional commissions and other intergovernmental bodies and forums.

2. In the light of the liquidity situation affecting the regular budget of the United Nations and the related management measures implemented by the Secretary-General, the synthesis of submissions is being discontinued. Instead, the information

The submissions have been organized in accordance with the Sustainable Development Goals that are under in-depth review in 2025, in accordance with General Assembly resolution 78/285.²
