**JOINT COMMUNIQUÉ  
ON  
THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
THE REPUBLIC OF MALAWI  
AND  
THE SOCIALIST REPUBLIC OF VIET NAM**

The Government of the Republic of Malawi and the Government of the Socialist Republic of Viet Nam,

Desirous of promoting and strengthening relations of friendship and cooperation in political, economic, social and humanitarian and other fields between their countries on the basis of equality and mutual respect for each other's sovereignty, independence and territorial integrity as well as non-interference in the internal affairs of each other,

Believing in the development of these essential relations on the basis of principles of the Charter of the United Nations and norms of international law,

Convinced that the establishment of diplomatic relations corresponds with the national interests of both countries and will contribute to the cooperation and peace in the world,

Have agreed to establish diplomatic relations at the Ambassadorial level as of the date of signature of this Joint Communiqué, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in New York, in two original copies, on 23 September, 2024, in English, both texts being equally authentic.
