#### Financing of the United Nations Multidimensional Integrated Stabilization Mission in Mali

**Draft resolution submitted by the Chair of the Committee following informal consultations**

#### **Financing of the United Nations Multidimensional Integrated Stabilization Mission in Mali**

*The General Assembly,*

*Having considered* the report of the Secretary-General on the financing of the United Nations Multidimensional Integrated Stabilization Mission in Mali<sup>1</sup> and the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup>

*Recalling* Security Council resolution [2100 \(2013\)](#) of 25 April 2013, by which the Council established the United Nations Multidimensional Integrated Stabilization Mission in Mali, and the subsequent resolutions by which the Council extended the mandate of the Mission, the latest of which was resolution [2690 \(2023\)](#) of 30 June 2023, by which the Council decided to terminate as of 30 June 2023 the mandate of the Mission under resolution [2640 \(2022\)](#) of 29 June 2022,

*Recalling also* its resolution [67/286](#) of 28 June 2013 on the financing of the Mission and its subsequent resolutions thereon, the latest of which was resolution [78/250 B](#) of 28 June 2024,

*Reaffirming* the general principles underlying the financing of United Nations peacekeeping operations, as stated in its resolutions [1874 \(S-IV\)](#) of 27 June 1963, [3101 \(XXVIII\)](#) of 11 December 1973 and [55/235](#) of 23 December 2000,

1. *Takes note* of the status of contributions to the United Nations Multidimensional Integrated Stabilization Mission in Mali as at 30 April 2025, including the contributions outstanding in the amount of 252 million United States dollars, representing some 2.1 per cent of the total assessed contributions, notes with concern that only 82 Member States have paid their assessed contributions in full, and urges all other Member States, in particular those in arrears, to ensure payment of their outstanding assessed contributions;

2. *Expresses its appreciation* to those Member States that have paid their assessed contributions in full, and urges all other Member States to make every possible effort to ensure payment of their assessed contributions to the Mission in full;

3. *Expresses concern* at the financial situation with regard to peacekeeping activities, in particular as regards the reimbursements to troop contributors that bear additional burdens owing to overdue payments by Member States of their assessments;

4. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions, and requests the Secretary-General to ensure their full implementation;

**Budget performance report for the period from 1 July 2023 to 30 June 2024**

5. *Takes note* of the report of the Secretary-General on the budget performance of the Mission for the period from 1 July 2023 to 30 June 2024;

6. *Also takes note* of the amount of 129,319,400 dollars comprising the unencumbered balance of 33,055,800 dollars in respect of the financial period ended 30 June 2024 and other revenue in the amount of 96,263,600 dollars in respect of the same period, and decides to defer action thereon until it considers the final performance report of the Mission;

7. *Further takes note* of the amount of 3,230,600 dollars representing the decrease in estimated staff assessment income in respect of the financial period ended 30 June 2024, and decides to defer action thereon until it considers the final performance report of the Mission;

8. *Decides* to include in the provisional agenda of its eightieth session the item entitled “Financing of the United Nations Multidimensional Integrated Stabilization Mission in Mali”.
