

Financing of the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic

Report of the Fifth Committee

I. Introduction

- 1. At its 2nd plenary meeting, on 13 September 2024, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-ninth session the item entitled "Financing of the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic" and to allocate it to the Fifth Committee.
- 2. The Fifth Committee considered the item at its 31st and 38th meetings, on 5 May and 25 June 2025. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records. ¹
- 3. For its consideration of the item, the Committee had before it the following documents:
- (a) Report of the Secretary-General on the budget performance of the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic for the period from 1 July 2023 to 30 June 2024 (A/79/670);
- (b) Report of the Secretary-General on the budget for the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic for the period from 1 July 2025 to 30 June 2026 (A/79/765 and A/79/765/Corr.1);
- (c) Related report of the Advisory Committee on Administrative and Budgetary Questions (A/79/724/Add.13).

II. Consideration of draft resolution A/C.5/79/L.42

- 4. At its 38th meeting, on 25 June, the Committee had before it a draft resolution entitled "Financing of the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic" (A/C.5/79/L.42), submitted by the Chair of the Committee on the basis of informal consultations coordinated by the representative of Paraguay.
- 5. At the same meeting, the Committee adopted draft resolution A/C.5/79/L.42 without a vote (see para. 6).

III. Recommendation of the Fifth Committee

6. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

Financing of the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic

The General Assembly,

Having considered the reports of the Secretary-General on the financing of the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic¹ and the related report of the Advisory Committee on Administrative and Budgetary Questions,²

Recalling Security Council resolution 2149 (2014) of 10 April 2014, by which the Council established the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic as from 10 April 2014 for an initial period until 30 April 2015, and the subsequent resolutions by which the Council extended the mandate of the Mission, the latest of which was resolution 2759 (2024) of 14 November 2024, by which the Council extended the mandate of the Mission until 15 November 2025,

Recalling also its resolution 68/299 of 30 June 2014 on the financing of the Mission and its subsequent resolutions thereon, the latest of which was resolution 78/298 of 28 June 2024,

Reaffirming the general principles underlying the financing of United Nations peacekeeping operations, as stated in its resolutions 1874 (S-IV) of 27 June 1963, 3101 (XXVIII) of 11 December 1973 and 55/235 of 23 December 2000,

Mindful of the fact that it is essential to provide the Mission with the financial resources necessary to enable it to fulfil its responsibilities under the relevant resolutions of the Security Council,

- 1. Requests the Secretary-General to entrust the Head of Mission with the task of formulating future budget proposals in full accordance with the provisions of its resolutions 59/296 of 22 June 2005, 60/266 of 30 June 2006, 61/276 of 29 June 2007, 64/269 of 24 June 2010, 65/289 of 30 June 2011, 66/264 of 21 June 2012, 69/307 of 25 June 2015, 70/286 of 17 June 2016 and 76/274 of 29 June 2022, as well as other relevant resolutions;
- 2. Takes note of the status of contributions to the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic as at 30 April 2025, including the contributions outstanding in the amount of 411.5 million United States dollars, representing some 3.7 per cent of the total assessed contributions, notes with concern that only 89 Member States have paid their assessed contributions in full, and urges all other Member States, in particular those in arrears, to ensure payment of their outstanding assessed contributions;
- 3. Expresses its appreciation to those Member States that have paid their assessed contributions in full, and urges all other Member States to make every possible effort to ensure payment of their assessed contributions to the Mission in full;

- 4. Expresses concern at the financial situation with regard to peacekeeping activities, in particular as regards the reimbursements to troop contributors that bear additional burdens owing to overdue payments by Member States of their assessments;
- 5. *Emphasizes* that all future and existing peacekeeping missions shall be given equal and non-discriminatory treatment in respect of financial and administrative arrangements;
- 6. Also emphasizes that all peacekeeping missions shall be provided with adequate resources for the effective and efficient discharge of their respective mandates;
- 7. Requests the Secretary-General to ensure that proposed peacekeeping budgets are based on the relevant legislative mandates;
- 8. Endorses the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions, subject to the provisions of the present resolution, and requests the Secretary-General to ensure their full implementation;
- 9. *Decides* to abolish the post of Public Information Assistant (G-5) in the Strategic Communications and Public Information Service that has been vacant for more than 24 months;
- 10. Requests the Secretary-General to ensure the full implementation of the relevant provisions of its resolutions 59/296, 60/266, 61/276, 64/269, 65/289, 66/264, 69/307, 70/286 and 76/274;
- 11. Also requests the Secretary-General to take all action necessary to ensure that the Mission is administered with a maximum of efficiency and economy;

Budget performance report for the period from 1 July 2023 to 30 June 2024

12. *Takes note* of the report of the Secretary-General on the budget performance of the Mission for the period from 1 July 2023 to 30 June 2024;³

Budget estimates for the period from 1 July 2025 to 30 June 2026

13. Decides to appropriate to the special account for the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic the amount of 1,297,912,500 dollars for the period from 1 July 2025 to 30 June 2026, inclusive of 1,174,132,000 dollars for the maintenance of the Mission, 97,894,200 dollars for the support account for peacekeeping operations, 13,602,400 dollars for the United Nations Logistics Base at Brindisi, Italy, and 12,283,900 dollars for the Regional Service Centre in Entebbe, Uganda;

Financing of the appropriation for the period from 1 July 2025 to 30 June 2026

- 14. Decides to apportion among Member States the amount of 486,717,100 dollars for the period from 1 July to 15 November 2025, in accordance with the levels updated in its resolution 79/250 of 24 December 2024, taking into account the scale of assessments for 2025, as set out in its resolution 79/249 of 24 December 2024;
- 15. Also decides that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among Member States, as provided for in paragraph 14 above, their respective share in the Tax

Equalization Fund of 12,442,900 dollars, comprising the estimated staff assessment income of 7,929,100 dollars approved for the Mission, the prorated share of 3,372,800 dollars of the estimated staff assessment income approved for the support account, the prorated share of 581,600 dollars of the estimated staff assessment income approved for the United Nations Logistics Base and the prorated share of 559,400 dollars of the estimated staff assessment income approved for the Regional Service Centre:

- 16. Further decides to apportion among Member States the amount of 811,195,400 dollars for the period from 16 November 2025 to 30 June 2026, at a monthly rate of 108,159,375 dollars, in accordance with the levels updated in its resolution 79/250, taking into account the scale of assessments for 2025 and 2026, as set out in its resolution 79/249, subject to a decision of the Security Council to extend the mandate of the Mission;
- 17. Decides that, in accordance with the provisions of its resolution 973 (X), there shall be set off against the apportionment among Member States, as provided for in paragraph 16 above, their respective share in the Tax Equalization Fund of 20,738,400 dollars, comprising the estimated staff assessment income of 13,215,100 dollars approved for the Mission, the prorated share of 5,621,500 dollars of the estimated staff assessment income approved for the support account, the prorated share of 969,400 dollars of the estimated staff assessment income approved for the United Nations Logistics Base and the prorated share of 932,400 dollars of the estimated staff assessment income approved for the Regional Service Centre;
- 18. Also decides that, for Member States that have fulfilled their financial obligations to the Mission, there shall be set off against the apportionment, as provided for in paragraphs 14 and 16 above, their respective share of the unencumbered balance and other revenue in the amount of 30,424,100 dollars in respect of the financial period ended 30 June 2024, in accordance with the levels updated in its resolution 76/239 of 24 December 2021, taking into account the scale of assessments for 2024, as set out in its resolution 76/238 of 24 December 2021;
- 19. Further decides that, for Member States that have not fulfilled their financial obligations to the Mission, there shall be set off against their outstanding obligations their respective share of the unencumbered balance and other revenue in the amount of 30,424,100 dollars, in respect of the financial period ended 30 June 2024, in accordance with the scheme set out in paragraph 18 above;
- 20. Decides that the increase of 1,539,200 dollars in the estimated staff assessment income in respect of the financial period ended 30 June 2024 shall be added to the credits in the amount of 30,424,100 dollars referred to in paragraphs 18 and 19 above;
- 21. Encourages the Secretary-General to continue to take additional measures to ensure the safety and security of all personnel participating in the Mission under the auspices of the United Nations, bearing in mind paragraphs 5 and 6 of Security Council resolution 1502 (2003) of 26 August 2003;
- 22. *Invites* voluntary contributions to the Mission in cash and in the form of services and supplies acceptable to the Secretary-General, to be administered, as appropriate, in accordance with the procedure and practices established by the General Assembly;
- 23. Decides to include in the provisional agenda of its eightieth session the item entitled "Financing of the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic".
