



Annotations

1. Solemn declaration by the newly elected members of the Committee

In accordance with rule 11 of the Committee's rules of procedure, upon assuming their duties, the newly elected members of the Committee will make the following solemn declaration:

I solemnly declare that I shall perform my duties and exercise my powers as a member of the Committee on Enforced Disappearances independently, objectively, honourably, faithfully, impartially and conscientiously.

2. Election of the officers

In accordance with rule 15 of the rules of procedure, the Committee will elect from among its members a Chair, three Vice-Chairs and a Rapporteur, with due regard to equitable geographical representation. In electing its officers, the Committee shall also give consideration to appropriate gender balance and, to the extent possible, rotation among members.

3. Adoption of the agenda

In accordance with rule 8 of the rules of procedure, the first item on the provisional agenda for any session is to be the adoption of the agenda, except for the election of the officers. Under this item, the Committee will consider and adopt the agenda for its twenty-ninth session.

4. Tribute to victims of enforced disappearance

The Committee will pay tribute to victims of enforced disappearance.

5. Reports by Committee members on activities undertaken between the twenty-eighth and twenty-ninth sessions of the Committee

The Committee members will share information regarding activities that they have undertaken in relation to the Convention between the twenty-eighth and twenty-ninth sessions.

6. Matters relating to the Committee's methods of work, thematic areas of work and ad hoc activities

(a) Follow-up to the thirty-sixth and thirty-seventh meetings of Chairs of the human rights treaty bodies

The Committee will discuss the outcomes of the thirty-sixth and thirty-seventh meetings of Chairs of the human rights treaty bodies and take necessary actions in view thereof.

(b) Review of the Committee's methods of work

The Committee will continue to review its methods of work to align them with the amended rules of procedure and with the outcome of the thirty-seventh meeting of Chairs of the human rights treaty bodies.

(c) Women and enforced disappearance

The Committee will review the information received in response to the call for inputs and the regional consultations on the project of the draft general comment on women and enforced disappearance.

(d) Transnational enforced disappearance

The Committee will consider a draft document on transnational enforced disappearance and take a decision regarding a possible course of action on the issue.

(e) Gender identity, sexual orientation and enforced disappearance

The Committee will consider a draft document on gender identity, sexual orientation and enforced disappearance and decide on a course of action on the issue.

(f) Communication strategy of the Committee

The Committee will pursue its exchanges with the Communications and Public Mobilization Section of the Office of the United Nations High Commissioner for Human Rights to explore concrete action to be taken to raise awareness about enforced disappearance and provide further information about the Committee's work.

(g) Follow-up to the World Congress on Enforced Disappearances

The Committee will assess the action taken in follow-up to the pledges made and priority action points defined during the Congress and identify potential additional related actions.

(h) Other matters

The Committee will discuss any other matters relating to its methods of work, thematic areas of work and ad hoc activities.

7. Consideration of lists of issues under article 29 (1) of the Convention

The Committee will consider and adopt lists of issues on the reports submitted by Finland (CED/C/FIN/1), Oman (CED/C/OMN/1) and Slovenia (CED/C/SVN/1).

8. Lists of priority themes under article 29 (3) and (4) of the Convention

The Committee will discuss the drafting of lists of priority themes related to the upcoming reviews of the additional information submitted by Ecuador (CED/C/ECU/AI/1) and Iraq (CED/C/IRQ/AI/2) pursuant to article 29 (3) and (4) of the Convention.

9. Consideration of reports of States Parties under article 29 (1) of the Convention

The Committee will consider the reports submitted by Benin (CED/C/BEN/1) and Sri Lanka (CED/C/LKA/1) pursuant to article 29 (1) of the Convention.

10. Consideration of additional information from States Parties under article 29 (4) of the Convention

The Committee will consider the additional information submitted by Montenegro (CED/C/MNE/AI/1) pursuant to article 29 (4) of the Convention.

11. Consideration of the report on requests for urgent action under article 30 of the Convention and of updates related to the management of the procedure

The Committee will consider the report on requests for urgent action received and follow-up action taken since the twenty-eighth session, and updates related to the management of the procedure.

12. Follow-up to Views of the Committee

The Committee will consider the report of the rapporteur on follow-up to Views pursuant to article 31 of the Convention and rule 81 of the rules of procedure.

13. Visits by the Committee under article 33 of the Convention

The Committee will address any issues related to visits that it has requested or plans to request pursuant to article 33 of the Convention. In that context, it will follow up on developments related to the reports on its visits to Colombia (CED/C/COL/VR/1 (Findings) and CED/C/COL/VR/1 (Recommendations)), Iraq (CED/C/IRQ/VR/1 (Findings) and CED/C/IRQ/VR/1 (Recommendations)) and Mexico (CED/C/MEX/VR/1 (Findings) and CED/C/MEX/VR/1 (Recommendations)).

14. Procedure under article 34 of the Convention

The Committee will analyse the information received following the activation of the procedure under article 34 of the Convention as relates to Mexico and will consider any other relevant information received.

15. Launch of the joint statement on so-called "short-term enforced disappearances"

Together with the Working Group on Enforced or Involuntary Disappearances and other international bodies that work on issues related to enforced disappearance, the Committee will initiate the activities related to the launch of the joint statement on so-called "short-term enforced disappearances".

16. Reprisals

The rapporteur on reprisals will report on action taken regarding any allegations of reprisals received since the twenty-seventh session of the Committee.

17. Annual and bilateral meetings with States Members of the United Nations

Without prejudice to the possibility of holding bilateral meetings, the Committee will hold its annual meeting with States Parties and States signatories to the Convention and other States Members of the United Nations to discuss topics relevant to the Convention.

18. Annual and bilateral meetings with United Nations agencies and mechanisms and intergovernmental organizations

Without prejudice to the possibility of holding bilateral meetings, the Committee will hold its annual meeting with United Nations agencies and mechanisms and with intergovernmental organizations that work on issues related to enforced disappearance.

19. Annual and bilateral meetings with civil society actors, national human rights institutions and other stakeholders

Without prejudice to the possibility of holding bilateral meetings, the Committee will hold its annual meeting with civil society actors, national human rights institutions and other stakeholders on the situation of enforced disappearance in States Parties to be considered at the twenty-ninth session and on matters relating to the implementation of the Convention.
