Extensions of ongoing country programmes

Note by the secretariat

Summary

In accordance with Executive Board decision 2009/11, this note informs the Executive Board of the first two-month extensions of the country programmes for Argentina, Eswatini, Georgia, Malaysia, Mexico and Somalia; the two-month extension of the country programme for South Africa, the second consecutive extension; and the first one-year extensions of the country programmes for Lebanon, Libya, Panama, Tunisia and Uruguay, all of which were approved by the Executive Director.

This note further informs the Executive Board of the reasons for the proposed two-month extension of the country programme for Cuba, the second consecutive extension; the two-month extension of the Gulf Area subregional programme, the second consecutive extension; the two-month extension of the country programme for the Sudan, the fifth consecutive extension; the one-year extensions of the country programmes for Mali, the Syrian Arab Republic and Yemen, all the second consecutive extensions; the one-year extensions of the country programmes for Burkina Faso and Myanmar, both the fourth consecutive extensions; the one-year extension of the country programme for the Democratic People's Republic of Korea, the fifth consecutive extension; the two-year extension of the area programme for Palestinian children and women in Jordan, Lebanon, the Syrian Arab Republic and the State of Palestine; and the two-year extension of the country programme for Afghanistan, the sixth consecutive extension. The Executive Board is requested to approve these extensions.

Draft decision

The Executive Board

- 1. Takes note of the first two-month extensions of the country programmes for Argentina, Eswatini, Georgia, Malaysia, Mexico and Somalia; the two-month extension of the country programme for South Africa, the second consecutive extension; and the first one-year extensions of the country programmes for Lebanon, Libya, Panama, Tunisia and Uruguay, all of which were approved by the Executive Director and are presented in table 1.
- 2. Approves the proposed two-month extension of the country programme for Cuba, the second consecutive extension; the two-month extension of the Gulf Area subregional programme, the second consecutive extension; the two-month extension of the country programme for the Sudan, the fifth consecutive extension; the one-year extensions of the country programmes for Mali, the Syrian Arab Republic and Yemen, all the second consecutive extensions; the one-year extensions of the country programmes for Burkina Faso and Myanmar, both the fourth consecutive extensions; the one-year extension of the country programme for the Democratic People's Republic of Korea, the fifth consecutive extension; the two-year extension of the area programme for Palestinian children and women in Jordan, Lebanon, the Syrian Arab Republic and the State of Palestine; and the two-year extension of the country programme for Afghanistan, the sixth consecutive extension, all of which are presented in table 2.
