APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS

International Civil Service Commission: appointment of five members of the Commission; designation of the Chairman and Vice-Chairman of the Commission

Note by the Secretary-General

- 1. In his note of 20 April 1982 (A/37/186), the Secretary-General advised the General Assembly that the terms of office of five members of the International Civil Service Commission would expire on 31 December 1982 and that it would be necessary for the Assembly to fill the resulting vacancies for terms of office of four years beginning on 1 January 1983. The Assembly was also informed that it would be necessary to designate a Chairman and Vice-Chairman of the Commission.
- 2. The members of the Commission whose terms of office expire on 31 December 1982 are:
 - Mr. Richard M. Akwei (Ghana, Chairman)
 - Mr. Gastón de Prat Gay (Argentina, Vice-Chairman)
 - Mr. Moulaye El Hassen (Mauritania)
 - Mr. Pascal Frochaux (Switzerland)
 - Mr. Jiři Nosek (Czechoslovakia)
- 3. In his note of 27 September 1982 (A/37/186/Add.1), the Secretary-General advised the General Assembly that Mr. Akira Matsui (Japan) had resigned from membership of the International Civil Service Commission and that, accordingly, it would be necessary for the Assembly to appoint one person to fill the unexpired portion of the term of office of Mr. Matsui, i.e. until 31 December 1984.
- 4. The appointment of members of the International Civil Service Commission is governed by the provisions of articles 4 and 5 of the Commission's statute.

Pursuant to these provisions, the Secretary-General has undertaken consultations with Member States through the Chairmen of the various regional groups, with the executive heads of the other organizations, with staff representatives through the Federation of International Civil Servants Associations (FICSA) and with the Advisory Committee on Administrative and Budgetary Questions (ACABQ).

- 5. On the basis of these consultations, the Secretary-General, in his capacity as Chairman of the Adminstrative Committee on Co-ordination, is now in the position to suggest that the Fifth Committee recommend to the General Assembly the following appointments to the International Civil Service Commission:
 - (a) For four-year terms of office beginning 1 January 1983:
 - Mr. Richard M. Akwei as Chairman,
 - Mr. Gastón de Prat Gay as Vice-Chairman,
 - Mr. Moulaye El Hassen as member,
 - Mr. Jiři Nosek as member,
 - Mr. Dayton Hull as member.
 - (b) for a two-year term beginning 1 January 1983: Mr. Masao Kanazawa

GASTON DE PRAT GAY (Argentina)

Gastón de Prat Gay, appointed by the General Assembly in 1980 as Vice-Chairman of the International Civil Service Commission, was born in Tucumán, Argentina in 1934. He studied law at the University of Buenos Aires and holds a B.A. degree in journalism from the University of California at Berkeley and an M.A. and Ph.D. in international relations from the American University in Washington, D.C. Mr. de Prat Gay has taught Argentine foreign policy at the School of Political Science of the University of Salvador in Buenos Aires. He is the author of Política Internacional del Grupo Latinoamericano and The Latin American States and the Non-Aligned Movement.

Before joining the Argentine foreign service in 1959 as an attaché he practised journalism in New York, Mexico, Buenos Aires and Europe. In his diplomatic career he served as Press Adviser to the Foreign Minister, Counsellor in the Policy Planning Office, Deputy Director of the Foreign Service Institute and Chief of the North American Department. Abroad he served in the Argentine embassies in Washington, D.C. and Montevideo, Uruguay and in the Argentine Mission to the United Nations.

Mr. de Prat Gay's association with the United Nations goes back to 1960 when he was a member of his country's delegation to the fifteenth session of the General Assembly. Later on he participated in the sixteenth, twenty-seventh, twenty-eighth, twenty-ninth, thirtieth and thirty-first sessions of the General Assembly. He was delegate to the Fifth Committee (Administrative and Budgetary Questions) and deputy Permanent Representative of Argentina. He also attended as Alternate Representative of Argentina at the special session of the Security Council in Africa. Mr. de Prat Gay was a member of the delegation of Argentina to the sixth and seventh special sessions of the General Assembly and to the Fifth Conference of Foreign Ministers of the Non-Aligned Movement in Lima, Peru. He has participated in numerous inter-American meetings.

- 11. Chairman of the African Group at the United Nations, September 1973 and July 1976.
- 12. March-July 1975, head of the Mauritanian delegation to the International Court of Justice.
- 13. Mr. Moulaye El Hassen attended the third, ninth and tenth Summit Conferences of the Organization of African Unity and the fourth Summit Conference of the Non-Aligned Countries as a member of the Mauritanian delegation.
- 14. He headed the Mauritanian delegation to the Council of Ministers of the Non-Aligned Countries in Guyana in 1973.
- 15. Member of the International Civil Service Commission since 1 January 1979.
