Survey of the Situation in India

The Government of India has submitted the following corrections to the Survey of the Cannabis Situation in India (document E/CN.7/286/Add.12).

Page 5: In paragraph II(b)(2), for the words "AREAS I INDIA SOWN" substitute the words "AREAS IN INDIA SOWN".

Page 5: In the second line of paragraph IV(a), the word "Assma" should be substituted by "Assam".

Page 5: In the second line of paragraph IV(a) the word "Madras" should be deleted.

Page 5: In the fifth line of paragraph IV(a) the word "Madras" should be inserted between the words "Bombay" and "Kutch".

Page 5: In the seventh line of paragraph IV(a) the word "Bhopol" should be substituted by the word "Bhopal".

Page 6: In the table appended to paragraph B.I. against the word "Punjab" the following quantities should be substituted for those at present given:

1947	1948	1949	1950	1951	1952	1953	1954
71.4	68.4	74.4	72.4	81.3	80.9	80.8	73.0

Page 14: In the heading of the table the figure "1953" should be replaced by "1954".

Page 18: In the table against the entry "Andhra" (No.27) the word "Medical" appearing in columns 2 and 3 should be replaced by the word "medicinal".

Page 19: In footnote (c) the word "Gurgaoh" should be replaced by "Gurgaon".

Page 20: In the table against the entry "Bihar" (No.2) the following quantities should be substituted:

1952	1953	1954
Ganja	Ganja	Ganja

Page 20: In the table against the entry "Orissa" (No.6), in the column for 1954 (Ganja), the figure 4,954 should be substituted for the present figure of 5,954.

Page 20: In the table against the entry "Hyderabad" (No.10) in the column for 1952 (Ganja), the figure 5,810 should be substituted for the present figure of 8,510.

Page 20: In the table against the entry "Madhya Bharat" (No.12), in the column for 1951 (Ganja), an "(a)" should be inserted after the figure 13,553.

Page 20: In the table against the entry "Grand Total" the following figures should be substituted:

<u>1952</u> (Ganja)	<u>1953</u> (Ganja)	<u>1954</u> (Ganja)
74,354	67,921	85,087

Page 28: In the seventh line the word "Dussenhra" should be replaced by the word "Dussehra".

Page 31: In the table under the column "State", the entry "Andaman and Nocobar Islands" should be replaced by the words "Andaman and Nicobar Islands".

Page 32: In the table against the entries for Madhya Bharat and Manipur (Nos.12 and 24), the "(a)" appearing under the column "Ganja" should be deleted.

Page 32: In the footnote the words "(a) The figures investigated (18)" should be deleted.

Page 35: In line 4 of section (f), ~~the words "during 1954" should be inserted~~ after the words "Cochin Port".

Page 44: In the table against the entry "Punjab" the figure "266" in the last column should be replaced by "226".

Page 45: In the second line of section V, the words "except cannabis resin" should be inserted after the word "cannabis".

Page 52: Against item "15. Madhya Bharat", in the second line, the word "on" should be replaced by the word "of".

Page 56: The letter "(a)" in footnotes (19) and (20) should be deleted.

Page 58: At the end of the source reference numbered 18 the words "and with a note of 26 November 1956" should be added.
