## Приложение

### **Письменное заявление Национальной комиссии Кении по правам человека**

Your Excellency, Mr. President,

1. I am deeply honored to make this statement on behalf of the Kenyan NHRI, the Kenya National Commission on Human Rights (KNCHR/the Commission), an “A” Status NHRI under the Paris Principles.
2. The Commission commends the one-hundred and twenty-two (122) countries that have made recommendations to Kenya and welcomes the Government’s acceptance of the majority of the recommendations made to it. We further congratulate and laud the Kenyan Government for its active participation in the four cycles of the UPR.
3. The Commission appreciates the commendable efforts of the Kenyan Government Ministries, Departments and Agencies, Civil Society Organizations, as well as development partners, towards the implementation of recommendations under the UPR.
4. The Commission takes cognizance and supports the recommendations made to Kenya under the 4th cycle of the UPR on issues of:
  - a) Accession to the Optional Protocol to the Convention on the Rights of the Child on the sale of children, child prostitution and child pornography;
  - b) Investigations, prosecutions and accountability in all cases of extra-judicial killings, excessive use of force and enforced disappearance;
  - c) The full implementation of the Prevention of Torture Act;
  - d) Gender-based violence, femicide and emerging forms of violence against women and girls;
  - e) The realization of economic, social and cultural rights; and
  - f) Adoption of the National Policy and Action Plan on Human Rights by the Government.
5. We acknowledge the efforts made by the Government towards the recognition, protection and promotion of the rights of vulnerable groups, including intersex persons, persons with disabilities and indigenous communities. We call upon the Government to step up these measures to ensure the realisation of rights as set out under the Constitution, International treaties and Conventions that the State has ratified. We further call on the Government to enhance transparency and accountability measures in the use of social protection funds meant to cushion the most vulnerable in society.
6. The Commission reiterates its call for the State to abolish the death penalty, to fully operationalize the National Coroners Service Act, to ratify the Second Optional Protocol to the International Covenant on Civil and Political Rights, as well as the International Convention for the Protection of All Persons from Enforced Disappearance. The Commission continues to call for the lifting of the reservation on Article 14 (2) (c) of the Maputo Protocol. The Commission sustains its call for the Government of Kenya to fully implement the decision from the African Mechanisms on the Endorois, Ogiek and Nubian communities.
7. The KNCHR reiterates its call to the Government to support and implement these recommendations. Furthermore, the Commission urges the Government to enhance the ability of UN mandate holders to visit and conduct human rights missions in Kenya.
8. The Commission acknowledges that the State cannot implement the recommendations on its own. The Commission, therefore, calls upon the Government to intensify its collaboration with the Kenya National Commission on Human Rights, Civil Society Organizations and all other relevant stakeholders.
9. Finally, the Kenya National Commission on Human Rights calls upon development partners and civil society to offer technical and financial support to enable the State to meet its obligations within the fourth cycle.
