Cartas idénticas de fecha 6 de octubre de 2025 dirigidas al Secretario General y a la Presidencia del Consejo de Seguridad por el Representante Permanente de Israel ante las Naciones Unidas

En relación con mi carta de fecha 25 de junio de 2025, nuevamente me dirijo a usted para señalar a su atención una serie de violaciones cometidas por Hizbulah (véase el anexo*), que Israel documentó y presentó ante el Mecanismo Internacional de Vigilancia y Aplicación. Esta información demuestra que Hizbulah sigue desarrollando actividades que representan una amenaza directa para la seguridad de Israel, así como para la soberanía y la estabilidad del Líbano y de la región en general.

Por lo que se ha observado últimamente en el Líbano, Hizbulah está intentando reconstruir y ampliar su infraestructura militar sistemáticamente y por todos los medios posibles, con el respaldo del Irán, tanto al norte como al sur del Litani, en contravención de las resoluciones [1701 \(2006\)](#) y [1559 \(2004\)](#) del Consejo de Seguridad. Como podrá comprobar en el anexo de la presente carta, se ha documentado que Hizbulah ha colocado y reutilizado activos prefabricados para vigilar y volver a atrincherarse en el sur del Líbano, ha ocultado y desplegado lanzacohetes y tiene grandes depósitos de armamento tanto en la superficie como en instalaciones subterráneas. Además, se ha observado a agentes de Hizbulah reuniendo información y reconstruyendo campamentos militares, túneles y pozos, a menudo utilizando maquinaria de construcción pesada. Hizbulah sigue aumentando su arsenal de drones, y su capacidad, en particular local, de producir drones de ataque y de vigilancia. Además, cabe señalar que Hizbulah aún tiene un arsenal de decenas de miles de cohetes de diverso alcance, de los cuales al menos 1.000 son misiles guiados de precisión, y continúa utilizando deliberadamente a civiles libaneses como “escudo humano” al ubicar sus activos militares en zonas civiles.

La presencia física de la Fuerza Al-Quds del Irán en el territorio libanés hace patente que Teherán facilita y supervisa directamente esas actividades. Además, el Irán sigue enviando apoyo financiero a Hizbulah en vuelos directos e indirectos, por ejemplo a través de terceros países como Turquía. Tras la interrupción parcial de esas vías, Hizbulah empezó a recurrir más a las casas de cambio libanesas para transferir fondos. Se calcula que, desde que se declaró el alto el fuego en noviembre de 2024, esas redes han enviado a Hizbulah más de 1.000 millones de dólares de los Estados Unidos, lo que constituye una clara violación de las resoluciones pertinentes del Consejo de Seguridad.

Hizbulah ha intensificado el contrabando por tierra, mar y aire, y ha intentado restablecer rutas de contrabando de armas por la frontera sirio-libanesa utilizando contrabandistas locales, agentes y, al parecer, túneles. Además este caso excede el ámbito de la lista de violaciones, el 19 de agosto, las fuerzas sirias interceptaron un camión que transportaba misiles Grad desde Siria hacia el Líbano por la ruta de Homs, conocido corredor de tráfico ilegal que se extiende del suroeste de Homs al noreste de Bekaa. Este caso ilustrativo reciente tuvo lugar tras varios intentos de contrabando transfronterizo de misiles antitanque, lanzadores de misiles antitanque y lanzacohetes portátiles en zonas como Hermel y Al-Qusayr. Como demuestra esta interceptación, Hizbulah y el Irán están intentando adaptarse a la nueva realidad de Siria y mantener abierto un corredor terrestre para transferir armas y posiblemente fondos de Siria al Líbano. También se ha obtenido información de que se han reanudado las transferencias de armas desde el Irán hacia los puertos libaneses pasando por África (a través del Sudán y Libia).

Por otra parte, Hizbulah ha reactivado sus operaciones de narcotráfico. La producción de captagón se trasladó de Siria al valle de Bekaa (Líbano), y a finales de junio se interceptaron dos importantes cargamentos que se dirigían a Siria, en los que se decomisaron unos 3,5 millones de pastillas de captagón y 700 kilogramos de hachís.

Israel se mantiene fiel a su compromiso de aplicar los Entendimientos de Alto el Fuego alcanzados con el Líbano y sigue cooperando con el mecanismo dirigido por los Estados Unidos para vigilar el cumplimiento. Desde noviembre de 2024, ha denunciado cientos de violaciones que ha cometido Hizbulah, tanto de las resoluciones del Consejo de Seguridad como de los Entendimientos de Alto el Fuego. Sin embargo, hasta ahora no ha sido suficiente la respuesta que ha dado el Líbano: las Fuerzas Armadas Libanesas solo han respondido a un escaso número de esos incidentes, pero han desatendido muchos otros.

Habida cuenta de que el Gobierno del Líbano no está cumpliendo con seriedad las disposiciones, Israel se ve obligado a actuar unilateralmente. En agosto, Israel dirigió varios ataques contra infraestructura militar y subterránea de Hizbulah en el sur del Líbano —al norte del río Litani—, así como equipo de ingeniería y estructura civil reutilizada por Hizbulah para reconstruir la infraestructura terrorista al sur del Litani. Instamos al Gobierno del Líbano a que redoble los esfuerzos para asegurarse de que respeta las disposiciones y ayude a Israel a que no se vea obligado a emprender este tipo de operativos.

El Líbano tiene ante sí una oportunidad única de aplicar las disposiciones relativas al desarme de las resoluciones [1701 \(2006\)](#) y [1559 \(2004\)](#) del Consejo de Seguridad. El debilitamiento de Hizbulah gracias al reciente conflicto, así como el nuevo apoyo político del Líbano a la autoridad soberana, podría facilitar una reforma significativa que comprendiera el desarme de todas las milicias —tanto de Hizbulah como de las facciones palestinas— y el restablecimiento pleno de la soberanía libanesa. En este contexto, sigue siendo crucial fortalecer la independencia operacional y la capacidad coercitiva de las Fuerzas Armadas Libanesas, sobre todo a la luz de la resolución del Consejo de Seguridad por la que se pone fin al mandato de la Fuerza Provisional de las Naciones Unidas en el Líbano a más tardar a finales de 2026.
