## Report of the Second Committee

### I. Introduction

1. At its 2nd plenary meeting, on 12 September 2025, the General Assembly, on the recommendation of the General Committee, decided to allocate agenda items 15 to 24, 60, 121 and 137 to the Second Committee (see [A/80/251](#) and [A/C.2/80/1](#)).

2. At its 1st meeting, on 1 October 2025, the Committee approved its programme of work and decided to conduct its work in three phases. During the first phase, the Committee would hold its general debate and hear introductory statements and general discussions of each item. This would be followed by an intensive phase of informal consultations on draft proposals in accordance with a Bureau-approved calendar. The third phase would be for action on all draft proposals. Also at its 1st meeting, the Committee held a general discussion of item 137.<sup>1</sup>

3. At its 2nd to 5th, 8th and 10th meetings, on 6, 7, 9 and 10 October, the Committee held its general debate on the theme “Five years to 2030: multilateral solutions for sustainable development”.<sup>2</sup> At its 6th to 12th and 14th to 18th meetings, from 8 to 17 October and on 12 November, reports were introduced and the Committee held general discussions on items 15 to 24, 60 and 121.<sup>3</sup> The 13th meeting of the Committee, on 14 October, was convened jointly with the Economic and Social Council, on the theme “Reimagining public–investor partnerships: systems finance for inclusive sustainability transformations”.<sup>4</sup>

4. The Committee took action on all draft resolutions and decisions at its 18th to 22nd meetings, on 12 November and from 24 to 26 November. At those meetings,
