### Status of documentation

#### Note by the Secretariat

1. In accordance with paragraph 8 of the annex to Economic and Social Council resolution 2008 (LX) of 14 May 1976, the fortieth session of the Committee for Programme and Coordination will be held at Headquarters from 5 to 30 June 2000.
2. In its resolution 1988/77 of 29 July 1988 on the revitalization of the Economic and Social Council, the Council reiterated that the Secretariat should circulate the relevant documentation in all working languages six weeks before the opening of the sessions of the Council and its subsidiary organs.
3. In its resolutions 53/208 of 18 December 1998 and 54/248 of 23 December 1999, the General Assembly reiterated its request to the Secretary-General to ensure that documentation is available in accordance with the six-week rule for the distribution of documents simultaneously in the six official languages of the General Assembly; reaffirmed its decision that if a report is issued late, the reason for the delay should be indicated when the report is introduced, and decided further that, if a report is submitted late to conference services, the reasons for this should be included in a footnote to the document.
4. The General Assembly also reiterated its request that the Secretary-General direct all departments to include, where appropriate, the following elements in reports originating with the Secretariat:
  - (a) A summary report;
  - (b) Consolidated conclusions, recommendations and other proposed actions;
  - (c) Relevant background information.
5. The General Assembly further reiterated that all documents submitted to legislative organs by the Secretariat and expert bodies for consideration and action should have conclusions and recommendations in bold print.
6. In view of the date of the fortieth session of the Committee for Programme and Coordination, the documentation should be circulated by 21 April 2000. The documents to be issued for the fortieth session are listed in the annex to the present note.
