Subject: **Placement and promotion list for staff in the General Service and related categories**

\*\* The Secretary-General approved a list of alternate candidates proposed by the Department in accordance with the provisions outlined in Administrative Instruction ST/AI/1999/8. Should the selected candidate decline or fail to take up the functions for which he/she has been selected within two months, or vacate the post for any reason within six months of the Secretary-General's decision, another candidate from the short list may be selected by the Secretary-General on the recommendation of the head of department.

\*\*\* The Secretary-General approved the placement of the staff members against the post at their current level. The promotion of the staff members will be implemented when they have reached the established seniority in grade for regular promotion to the higher level.

\*\*\*\* The Secretary-General approved the staff member's accelerated promotion in accordance with personnel directive PD/1/94 of 6 July 1994.

\*\*\*\*\* The Secretary-General approved the placement of the staff member against the post at his current grade level. The promotion of the staff member will be implemented when he has reached the established seniority in grade for accelerated promotion to the higher level.

\*\*\*\*\* The Secretary-General has approved the promotion of the staff member to the G-5 level against a post at the G-6 level.

\*\*\*\*\* The Secretary-General approved the lateral transfer of the staff member in November 1999.
