

Mr. Sibal,

I would like to inform you of the situation in the Serbian province of Kosovo and Metohija which is in connection with your direct mandate.

Eight months after the deployment of KFOR and UNMIK, chaos and lawlessness are prevailing in Kosovo and Metohija. Continuing are terror, killings and arrests of remaining Serbs and Montenegrins primarily, who are not among those 350.000 persons displaced from Kosovo and Metohija since 12 June 1999.

In the period from 12 June until 6 February 2000 a total of 4249 terrorists acts were perpetrated in Kosovo and Metohija, of which 4030 against Serbs and Montenegrins. As many as 834 persons went missing or were abducted, 889 were killed and 784 wounded. Over 50.000 homes were destroyed and over 1000 private dwellings and houses were broken into and forcibly taken occupancy of. Over 80 mediaeval monasteries and churches were demolished. Such situation is a daily occurrence. My Government has informed of it on several occasions the United Nations, in particular the Security Council and the Secretary-General, as well as the High Commissioner for Human Rights, the Special Rapporteur for Bosnia and Herzegovina, Croatia and FR of Yugoslavia and others who were duty-bound to react and put an end to serious breaches of human rights and freedoms of the Serbian population primarily, and of the members of other ethnic groups in Kosovo and Metohija as well.

Contrary to provisions of the UN Security Council resolution 1244 (1999), parallel, quasi state authorities are established, comprised exclusively of Albanians as the only one of the numerous ethnic groups living in Kosovo and Metohija. Courts employ only Albanians - from the investigating judge to the president of the Court. Serbs are convicted and arrested without material evidence and written charges, while their being in custody is constantly prolonged, on the account of new "charges". People are arrested and kept in custody, as a rule, on the basis of Albanians informing against Serbs.

The systematic violation of human rights and fundamental freedoms of Serbs, Montenegrins, Roma, Goranci, Turks and other non-Albanian population is unacceptable to the FR of Yugoslavia, especially in the light of its duty to ensure to its entire population the respect for those international norms it had accepted by ratifying the relevant conventions of the UN.

Recalling the resolutions of the Commission on Human Rights entitled . "The issue on Arbitrary Detention" and recalling the mandate of the Working Group for Arbitrary Detention to collect from governments information on cases of arbitrarily detained persons, I would like to appeal to you that the Working Group most urgently take into consideration cases of Serbs arbitrarily arrested by KFOR and UNMIK in Kosovo and Metohija. Namely, a great many Serbs are detained in prisons in Pristina, Prizren, Sojevo near Ūrosevac, Kosovska Mitrovica, Gnjilane, Lipljan and Klokot Banja.

Recalling Articles 9 respectively of the Universal Declaration of Human Rights and International Covenant on Civil and Political Rights, I would like to reiterate that arbitrary deprivation of liberty is unacceptable. I consider it of utmost importance that the Working Group most urgently considers these issues with a view to taking necessary measures. For a better understanding of the facts in the field, please find enclosed a list with the so far known names of persons arbitrarily detained in Kosovo and Metohija.
