As I have already informed your Special Adviser on Cyprus Mr. Alvaro de Soto, during the second round of proximity talks held in Geneva from 31 January to 10 February 2000, we were contemplating announcing a number of unilateral good will measures aimed at further enhancing the living standards of the Greek Cypriot and Maronite residents of the Turkish Republic of Northern Cyprus.

On 5 May 2000, the Council of Ministers of the Turkish Republic of Northern Cyprus announced these measures, the English translation of which is attached for your perusal, in the form of a statement issued by the Turkish Republic of Northern Cyprus Ministry of Foreign Affairs and Defence.

I hope that these measures will be received by the Greek Cypriot side in the same spirit of good will that they have been made.

Statement by the Ministry of Foreign Affairs and Defence

The Council of Ministers of the Turkish Republic of Northern Cyprus announced the following measures on 5 May 2000:

- 1. All visa fees and exit charges except for one pound sterling processing fee or its equivalent in local currency (Turkish lira), have been waived. Monthly multiple entry and exit charge is ten pounds sterling or its equivalent in local currency (Turkish lira).
- 2. Greek Cypriots and Maronites who cross over to the Turkish Republic of Northern Cyprus to visit their close relatives can stay in the Turkish Republic of Northern Cyprus for a reasonable period by virtue of a permit given by the Ministry concerned. Application for extending the duration of stay for family and health reasons or other extenuating circumstances will be entertained by the said Ministry upon proper application.
- 3. The age restriction applied to Greek Cypriot students who are yet to fulfil military service and are continuing their education in Southern Cyprus who wish to visit their families (parents or grandparents) in the Turkish Republic of Northern Cyprus has been lifted.

The applicants have to produce the necessary documentation for proof of age and studentship.

- 4. In the event that a Greek Cypriot or Maronite residing in the Turkish Republic of Northern Cyprus marries a Greek Cypriot or Maronite or any other third party national residing outside Turkish Republic of Northern Cyprus territory, the spouse, on proof of marriage by production of relevant documents, will be permitted to take up residency in the Turkish Republic of Northern Cyprus in accordance with relevant Turkish Republic of Northern Cyprus legislation.
- 5. Freedom of movement throughout the territory of the Turkish Republic of Northern Cyprus, on par with Turkish Republic of Northern Cyprus citizens, is ensured.
- 6. Any Maronite or Greek Cypriot residing in the Turkish Republic of Northern Cyprus may apply for Turkish Republic of Northern Cyprus citizenship.
- 7. The above permits may be withdrawn at any time for reasons of security or law and order.
