# Chapter \_\_\_\_. Organizational matters

## I. Introduction

1. By a note dated 7 April 2000 from its Secretary, the Committee on Conferences authorized the Commission on the Status of Women acting as preparatory committee for the twenty-third special session of the General Assembly entitled "Women 2000: gender equality, development and peace for the twenty-first century" to hold a one-day resumed session in order to complete its work.

## II. Organization of the resumed session

2. The Commission acting as preparatory committee held a resumed session at United Nations Headquarters on \_\_\_\_\_. It held one meeting (6th) and a number of informal meetings.

3. The resumed session was opened by the Chairperson of the Commission acting as preparatory committee, Christine Kapalata (United Republic of Tanzania).

V, decision 2000/PC/2).

6. At the same meeting, the Commission acting as preparatory committee took note of a number of documents (see chap. V, decision 2000/PC/3).
