The first part of the thirty-Fourth session of the Trade and Development Board wae held at Geneva from 5 to 16 October and on 21 October 1987, when the Board adjourned until 19 November 1987, at: which time it would consider the report of the Ad Hoc Intergovernmental Working Group established by its decision 347 (XXXIV) on the in-depth study of the United Nations intergovernmental structure and functions in the economic and social fields (Economic and Social Council decision 1987/112). 352 (XXXIV). Ad Hoc Intergovernmental Working Group on the In-Depth Study of the United Nations Intergovernmental Structure and Functiona in the Economic and Social Fields

(Economic and Social Council decision 1987/112)

The Trade and Development Board,

Having considered the results of the work of the Ad Hoc Intergovernmental Working Group or. the In-Depth Study of the United Nations Intergovernmental Structure and Functions in the Economic rnd Social Fielde, established pursuant to Board decision 347 (XXXIV) of 15 October 1987,

- 1. <u>Endorses</u> the report of the Ad Hoc Intergovernmental Working Group) $\underline{1}$ /
- 2. Decides to transmit the report to the Special Commission of the Economic and Social Council on the In-Depth Study of the United Nations Intergovernmental Structure and Functions in the Economic and Social Fields, &8 requested in Economic and Social Council decision 1987/112 of 6 February 1987;
- 3. <u>Decides further</u> that the measures contained in the report as well as the relevant provisions of previous resolutions and decisions, particularly Board resolution 231 (XXII) of 20 March 1981, shall be effectively implemented within the URCTAD machinery, and <u>requests</u> the Secretary-General of UNCTAD to ensure the full implementation of those measures falling within his competence;
- 4. Requests the Secretary-General Of UNCTAD to bring to the attention of member States, via the consultation procedure established under Board resolution 231 ("XII), any developments that may affect the full implementation of the measures referred to in paragraph 3 above)
- 5. Decides to review in 1988, and thereafter on a regular basis, the measures agreed upon and to take, in that light, any action that may be needed with respect to the UNCTAD intergovernmental machinery, and to decide then on the periodicity of further reviews.

B. Decisions

347 (XXXIV). In-depth study of the United Nations intergovernmental structure and functions in the economic and social fields (Economic and Social Council decision 1987/112)

The Trade and Development Board,

Recalling General Assembly resolution 1995 (XIX) of 30 December 1964, as well as subsequent relevant resolutions and decisions concerning the mandate of UNCTAD, and resolutions and decisions of the General Assembly and of the United Nations Conference on Trade and Development pertinent to issues of rationalization,

Recalling also General Assembly resolution 41/213 of 19 December 1986, on the review of the efficiency of the administrative and financial functioning of the United Natione,

Further recalling Economic and Social Council decision 1987/112 of 6 February 1987, which established the special Commission of the Economic and Social Council on the In-Depth Study of the United Nations Intergovernmental Structure and Functions in the Economic and Social Fields, and which requested all subsidiary bodies of the General Accembly in the economic and social sectors:

'to submit to the Special Commission, within thirty days of the conclusion of their forthcoming sessions, their views and proposals on achieving the objective enviaaqed in recommendation 8 of the Group of High-level Intergovernmental Experts regarding their functioning and that of their subsidiary machinery" (para. (\underline{i})),

1. Decides:

- (a) To establish an ad hoc_intergovernmental working group for the purpose of elaborating, with the above objectives in mind, a report for consideration and action by the Board, in response to the request by the Council for a submission to the Special Commission;
- (b) That the Ad Hoc Working Group, drawing on past experience within IJNCTAD, will concentrate, in particular, on issues pertaining to possible further improvements in the methods of work of the intergovernmental machinery of UNCTAD, in the structure of that machinery in relation8 between UNCTAD and other bodies in the economic and social sectors of the United Nations;
- (c) That the Ad Hoc Working Group will be composed of 19 members as follower nine members from the Group of 77; six members from Group B; three members from Group D; and China; that it will be open to participation by all members of the Board, will hold formal and informal meetings as may be necessary, on the basis of available resources and facilities, and will have a Chairman and two Vice-Chairmen;
- 2. <u>Further decides</u> that the Ad Hoc Working Group will adopt its report by 13 November 1987 for submission to the resumed first part of the thirty-fourth session of the Trade and Development Board on 19 and 20 November 1987.

348 (XXXIV). UNCTAD's contribution to the implementation of the United Nations Programme of Action for African Economic Recovery and Development 1986-1990

The Trade and Development Board,

Recalling paragraphu 4 and 5 of General Assembly resolution S-13/2 of 1 June 1986.

Recalling also paragraph 1 of its decision 345 (XXXIII) of 3 Apt il 1987 stressing the importance of UNCTAD's contribution to the United Nations Programme of Action for African Economic Recovery and Development 1986-1990, 2/

Having considered the report by the Secretary-General of UNCTAD's contribution to the implementation of the United Nations Programme of Action for African Economic Recovery and Development 1986-1990, 3/ pursuant to its decision 345 (XXXIII) of 3 April 1987,

Emphasising that UNCTAD should continue its contribution to the implementation of the Programme of Action in areas within its competence and consistent with its mandate and programmes,

Rearing in mind the consultative process provided for in Doard decision 143 (XVI) of 23 October 1976 and its resolution 231 (XXII) of 20 March 1981,

- 1. Takes note of the report by the Secretary-General of UNCTAD;
- 2. Endorses the programme elements for the follow-up within UNCTAD of the United Nations Programme of Action for African Economic Recovery and Development 1986-1990 and requests the Secretary-General of UNCTAD to implement the programme elements which are annexed to the UNCTAD programme budget for the biennium 1988-1989; particular attention should be given, inter alla, to policies on commodity production and trade, debt management and the use of the generalized system of preferences;
- 3. Stresses the importance of strengthening UNCTAD's technical assistance activities within the context of the Programme of Action, making full use of the United Nations Development Programme and other available resources?
- 4. <u>Further endorses</u> the initiative of the Secretary-General of UNCTAD to prepare a report on the interaction between the external environment and the efforts of African countries in the implementation of the relevant provisions of the Programme of Action, bearing in mind the work being undertaken in other United Nations entities}
- 5. Requests the Secretary-General of UNCTAD to convene, &8 may be required, special consultations in order to assist in the mailtoring and consideration by the Board of activities relevant to the Programme of Action with a view to strengthening and accelerating its implementation within UNCTAD;

6. <u>Invites</u> States and intergovernmental and non-governmental organizations to contribute resources to support the activities of the secretariat in the implementation of the Programme of Action.

349 (XXXIV). Preparation for the global review and approximate of the implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries

The Trade and Development Board,

<u>Recalling</u> General Assembly resolution 40/205 of 17 December 1985 on the implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries,

Recalling also its decision 329 (XXXII) of 21 March 1986 on the global review and appraisal of the implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries,

Further recalling the Final Act of UNCTAD VII, 4/

Recommends to the General Assembly that:

- (a) A second United Nations conference on the least developed countries at high level should be convened in 1990;
 - (b) The mandate of the conference should be as follows:
 - (i) Review of progress at the country level thus far in the decade;
 - (11) Review of progress in the international support measures and particularly in official development assistance;
 - (iii) In the light of (i) and (ii) above, consideration and appropriate formulation and adoption of national and international policies and measures for accelerating the development process in the least developed countries during the 1990s in accordance with their long-term national social and economic objectives9
 - (c) The generous offer made hy France to host the conference be accepted9
 - (d) The conference should be held; n September 1990;
- (e) In order to prepare for the conference, one session of the Meeting of Governmental Expects of Donor Countries and Multilateral and Bilateral Financial and Technical Assistance Institutions with Representatives of the Least Developed Countries in the spring of 1989 followed by one session of the Intergovernmental Group on the Least Developed Countries (Preparatory Committee for the Second United Nations Conference on the Least Developed Countries) in early 1990 should be convened. The duration of these two meetings will he one and a half weeks and two

weeks respectively. The terms of reference of these meetings are annexed to the present decision.

ANNEX I

Meeting of Governmental Experts of Donor Countries and Multilateral and Bilateral Financial and Technical Assistance Institutions with Representatives of the Least Developed Courtries

Terms of reference.

The purpose of the meeting is to provide substantive inputs to the United Nations conference on the least developed countries, to be hold in 1990. Taking into account the Substantial New Programme of Action, the meeting will be devoted to:

- (a) Assessment of progress in the socio-economic situation of the least developed countries during the 1980s in tht light of ongoing national and international measures:
- (b) Consideration of least developed countries' requirements of particular relevance to their development which call for strengthened efforts during the 1990s;
- (c) Consideration and identification of appropriate national and international measures for accelerating the development process in the least developed countries during the 1990s;
- (d) The results of the deliberations under (a), (b) and (c) will be reported to the conference through the Intergovernmental Group on the Least Developed Countries.

Intergovernmental Group on the Least Developed Countries

(Preparatory Committee for the Second United Nation8

Conference on the Least Developed Countries)

Terms of reference

- (i) Substantive preparation for the conference on the basis of the report of the Meeting of Governmental Experts of Donor Countries and Multilateral and Bilateral Financial and Technical Assistance Institutions with Representatives of the Least Developed Countries, and of all other relevant inputs;
- (ii) Provisional agenda for the second 'Inited Nations conference on the least developed countries)

- (iii) Provisional rules of procedure of the conference;
 - (iv) Organization of work of the conference.

350 (XXXIV). Arrangements for the follow-up and review of the implementation of the Final Act of UNCTAD VII

The Trade and Development Board,

<u>Having considered</u> the note by the UNCTAD secretariat containing suggestions on arrangements for the follow-up and review of tnc implementation of the Final Act of UNCTAD VII, 5/

Decides:

- (a) That the intergovernmental bodies of UNCTAD, including those responsible for the preparation of the proposed second United Nations conference on the least developed countries, to be held in 1990, shall fallow up and keep under review the implementation of the policies and measures in the Final Act falling within their terms of reference, shall also keep under review the need to strengthen and adapt these policies and measures in the light of changing circumstances, and shall include the requisite provisions in their agenda)
- (b) To monitor the progress made by these intergovernmental bodies in carrying out these tasks and, taking account of progress achieved and of the work of other competent intergovernmental bodies, to keep under review, in accordance with its own terms of reference, the implementation of the Final Act;
- (c) In the context of its regular agenda item on "Interdependence of problems of trade, development finance and the international monetary system" and bearing in mind the implications for policy drawn by the Conference 6/to contribute:
 - (i) To the review of the interrelationships among the policies and measures set forth in the Final Act, drawing upon the results of the work undertaken by UNCTAD intergovernmental bodies in accordance with subparagraph (a) above);
 - (ii) To international co-operation aimed at iaproving the systems, structures and arrangements which underpin international economic relations, particularly in the interrelated areas of money, finance and trade, taking into account the related work of other intergovernmental bodies:
- (d) To consider how best to strengthen its regular review under the agenda item mentioned in subparagraph (c) above, taking account of the relevant provisions of the Final Act., and, with that purpose in view, to request the Secretary-General of UNCTAD to hold appropriate consultations under the arrangements established by its decision 338 (XXXIII) of 9 September 1986.

At its 718th meeting, on 15 October 1987, the Board, having adopted decision 347 (XXXIV) by which it set up an Ad Hoc Intergovernmental Working Group for the purpose of elaborating a report for consideration and action by the Board in response to the request In Economic and Social Council declalon 1987/112, elected Mr. Alloune Sene (Senegal) as Chairman of the Group, which would be composed of the following members: Group of 771 Ecuador) Egypt; India; Malaysia; Mexico; Senegal) Venezuela; Yugoslavia; United Republic of Tanzania; Group B; Canada; Denmark; Ireland, Sweden; Switzerland; United States of America; Group Dr Bulgaria; German Democratic Republic, Union of Soviet Socialist Republics; and China.
- 6. At ite 718th meeting, on 15 October 1987, he Board took note of the report of the Working Party on the Medium-term Plan and the Programme Budget on the first and second parts of Ite thirteenth session and of the agreed conclusions annexed thereto 29/ and agreed that the report should be transmitted to the appropriate United Nations bodies for their conrideration.

111. STATEMENTS MADE AT THE 719TH MEETING IN CONNECTION WITH ACTION TAKEN BY THE BOARD AT THE FIRST PART OF THE THIRTY-POURTH SESSION

A. Adoption of the report on credentials.

- 1. The representative of <u>Pakistan</u> said that his delegation wished to record its reservations with regard to the credentials of the representative of Afghanistan for the reasons stated by Pakistan during the forty-first session of the General Assembly.
- 2. The representative of <u>China</u> said with regard to the credentials of the representative of Afghanistan that the position of China as expressed during the forty-first session of the General Assembly remained unchanged.
 - B. Provisional agenda for the second part of the thirty-fourth session of the Board and organisation of the work of the session
- 3. At the 719th meeting, on 16 October 1987, the President informed the Board that informal consultations had been helen the provisional agenda for the second part of the thirty-fourth session in TD/b/L.827 and in that connection drew attention to paragraphs 2, 3 and 5 of that document, which read:
 - -2. The inclusion of item 4 of the provisional agenda, 'Review of the implementation of the guidelines contained in Board resolution 222 (XXI) ', is pursuant to decision 288 (XXVIII), which provided for such a review to be undertaken by the Board at its thirty-fourth session. The manner in which this item will be dealt with will be taken up in consultations to be undertaken by the Secretary-General.
 - "3. With regard to the possibility of including, in the provisional agenda for the second part of the thirty-fourth session, agenda items relating to interdependence of problems of trade, development finance and the internotional monetary system and debt development problems of developing countries, it may be recalled that, in accordance with Board decision 339 (XXXIII), these items would normally be dealt with at the first part of the Board's session and the Secretary-General of UNCTAD would consult with regional group co-ordinators regarding any major developments relating to items which might need to be taken up at either part of the session.

 Consequently, the opportunity remains open for any major developments concerning these items to be taken up at the second part of the thirty-fourth session should the consultations of the Secretary-General of UNCTAD reveal the need to do so.

• • •

"5. The Board might wish to authorize the Secretary-General of UNCTAD, in consultation with the President, to adjust and complete the draft provisional agenda in the light of developments, including action taken by the General Assembly at its forty-second session. This arrangement would be on the understanding that any amendments or additions would he subject to consultation with the representatives of regional groups within the framework of the consultative machinery established by Board decision 143 (XVI) and Board resolution 271 (XXII)."

- 4. The President stated that the procedure outlined in paragraph 5 would apply inter alia to any action which might be necessary in relation to preparations for the qlobal review and appraisal of the implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries.
- 5. There was an understanding that paragrapha 2, 3 and 5 of TD/B/L.827, as well as his present remarks, would be fully reflected in the report of the Board and would also be part of the provisional agenda when it was circulated for the second part of the thirty-fourth regular session.
- 6. In accordance with these underatandinga, and with decisions already taken at the current session, item 6 (a), "Preparations for the qlobal review and appraisal of the implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries", was deleted from the provisional agenda for the second part of the thirty-fourth session (see annex II below).
