^e The United Nations Transitional Administration in East Timor, established by Security Council resolution 1272 (1999) of 25 October 1999, is endowed with overall responsibility for the administration of East Timor, until the Territory achieves independence.

^f On 26 February 1976, the Permanent Representative of Spain to the United Nations informed the Secretary-General that “the Spanish Government, as of today, definitely terminates its presence in the Territory of the Sahara and deems it necessary to place the following on record: ... (a) Spain considers itself henceforth exempt from any responsibility of an international nature in connection with the administration of the said Territory, in view of the cessation of its participation in the temporary administration established for the Territory ...” (A/31/56-S/11997).
