Substantive session of 2000 New York, 5 July-1 August 2000 Agenda item 12* Non-governmental organizations

Report of the Committee on Non-Governmental Organizations on the first and second part of its 2000 session (New York, 15-19 May and 12-23 June 2000)

Summary

At its 2000 session, from 15 to 19 May and 12 to 23 June 2000, the Committee on Non-Governmental Organizations had before it 80 new applications for consultative status and 37 applications deferred from its 1998 and 1999 sessions. Of those applications, the Committee recommended that the Economic and Social Council grant consultative status to 37 organizations, that the Council not grant consultative status to five organizations, that the applications of two organizations be resubmitted and that the file of one organization be closed. The Committee also deferred further consideration of 72 applications to a later date, and recommended that one organization be reclassified from special to general consultative status.

The present report contains four draft decisions on matters calling for action by the Economic and Social Council.

By draft decision I, the Council would:

(a) Grant consultative status to 37 non-governmental organizations;

(b) Reclassify one organization from special to general consultative status;

(c) Not grant consultative status to five non-governmental organizations;

(d) Decide to close consideration of the application of one non-governmental organization;

(e) Decide that the applications of two non-governmental organizations be resubmitted;

(f) Decide that one non-governmental organization reapply as a new legal entity.

By draft decision II, the Council would suspend the consultative status of two organizations, the International Council for the Association for Peace in the Continents and the Transnational Radical Party, for three years each.

By draft decision III, the Council would authorize the Committee to hold a resumed session for a period of two weeks in January/February 2001 to complete the work of its 2000 regular session.

By draft decision IV, the Council would take note of the present report and approve the provisional agenda for the 2001 session of the Committee.

(d) Close its consideration of the Council for the Defence of Human Rights and Freedom;

(e) That the applications of the following two organizations be resubmitted to the Committee at a later stage since these organizations had not yet been in existence for the mandatory two years to qualify for consideration, as follows:

(i) Hague Appeal for Peace will resubmit its application to the Committee at its 2000 resumed session;

(ii) Dominicans for Justice and Peace will resubmit its application to the Committee at its 2001 regular session;

(f) That the non-governmental organization Safari Club International should reapply as the Safari Club International Foundation when it fulfils the mandatory two years of existence to qualify for consideration of consultative status.

Draft decision II Suspension of consultative status

The Economic and Social Council decides to suspend, for a period of three years, the special consultative status of the International Council of the Associations for Peace in the Continents and the general consultative status of the Transnational Radical Party in accordance with paragraph 57 of the Economic and Social Council resolution 1996/31 of 25 July 1996.

Draft decision III Resumed 2000 session of the Committee on Non-Governmental Organizations

The Economic and Social Council decides to authorize the Committee on Non-Governmental Organizations to hold a resumed session for a period of two weeks, in January/February 2001, in order to complete the work of its 2000 session.
