Subject: Revised salary scales for staff in the General Service, Security Service, and Public Information Assistant categories at Headquarters**

- 1. In accordance with article 12 of its statute, the International Civil Service Commission (ICSC) undertook a comprehensive survey of the best-prevailing conditions of employment in New York for the purpose of making recommendations to the Secretary-General on salary scales of staff in the General Service and related categories at Headquarters. Representatives of the Administration and the staff actively participated in all aspects of the survey, including, inter alia, the selection of employers and jobs to be surveyed and the subsequent collection and analysis of data. The Commission completed its work at its July/August 2000 session and has made its recommendations.
- 2. I am pleased to announce that, based on the recommendations of the Commission, as contained in its report for the July/August 2000 session, the Secretary-General has decided to promulgate the revised salary scales for staff in the General Service, Security Service and Public Information Assistant categories at Headquarters as proposed by ICSC. The Secretary-General has further decided that these scales should be implemented with effect from 1 May 2000, since salary data collected by the Commission relate to that month. The revised salary scales are set out in annexes I and II to the present information circular.
- 3. The Commission concluded that the results of the survey for the General Service category warranted a 2.92 per cent increase over current net salaries (1 January 1999). The Secretary-General has approved a salary scale, effective 1 January 2000, to reflect the 2.00 per cent cost-of-living adjustment, which was warranted in January 2000. The remaining amount has been incorporated into a revised salary scale approved for the General Service, with effect from 1 May 2000.
- 4. The analysis of the data collected for the Security Service resulted in an overall increase of 7.66 per cent over current net salaries (1 January 1999). Thus, in

accordance with procedures established for the General Service category, a salary scale has been approved, with effect from 1 January 2000, to reflect the payment of the 2.00 per cent cost-of-living adjustment which was warranted in January 2000. The remaining amount has been incorporated into a revised salary scale approved for the Security Service, with effect from 1 May 2000.

- 5. The survey conducted for the Public Information Assistants was unable to identify comparators with which to make viable comparisons in the New York labour market. Consequently, in view of the continuing difficulties encountered in surveying Public Information Assistants, the Commission has recommended that the salary scale for this group of staff be reviewed in the light of the decisions taken on the salary survey for the New York General Service category. On that basis, the Secretary-General has also approved a 2.92 per cent increase for this category of staff. A new salary scale is being approved, with effect from 1 January 2000, to reflect the payment of the 2.00 per cent cost-of-living adjustment which was warranted in January 2000. A revised salary scale has also been approved, with effect from 1 May 2000, to reflect the remaining amount.
- 6. The survey exercise for the Trades and Crafts is nearing completion. Data are being awaited from certain comparator employers. The analysis will be completed as soon as the data are received and will be presented to the Chairman of ICSC for final review and approval, as delegated to him by the Commission.
- 7. With regard to the Language Teachers survey, the Commission has indicated that every effort should be made to enhance employer participation. The results of this survey will be presented at the next session of the Commission. However, ICSC recommended that the 2.00 per cent cost-of-living adjustment which was warranted in January 2000 should be granted, with effect from 1 January 2000; the salary scale for this category of staff will be announced separately.
- 8. The amounts of the dependency allowances are recalculated in the context of the salary survey. In this connection, the Commission recommended the revision of the amounts of dependency allowances for the General Service and related categories in New York on the basis of tax abatements provided under United States federal, state and city fiscal legislation. The revised amounts of dependency allowances are \$1,803 for dependent child and \$1,303 for secondary dependant, effective 1 May 2000, which is the reference month of the survey. The dependency allowances for dependent spouse and for the first dependent child of a single, widowed or divorced staff member remain unchanged.
- 9. The implementation of the revised salary scales in the preceding paragraphs will be reflected at the end of August 2000. Those former staff members who left the service of the United Nations between 1 January and 31 July 2000 will be eligible to receive the retroactive increases that have resulted from the implementation of the revised salaries upon presentation of a written claim to their former executive offices. Such claims must be made within one year of the date of issuance of the present information circular.
