Should the selected candidate decline or fail to take up the functions for which he/she has been selected within two months, or vacate the post for any reason within six months of the Secretary-General's decision, another candidate from the shortlist may be selected by the Secretary-General on the recommendation of the head of department.

^{***} The Secretary-General approved the placement of the staff member against the post at his current level. The promotion of the staff member will be implemented when he has reached the established seniority in grade for accelerated promotion to the higher level.

^{****} The Secretary-General approved the promotion of the staff member in October 1999. His promotion will be effective when he has reached the minimum seniority in grade for accelerated promotion to the P-4 level.
