Item 1. Opening of the informal meeting

- 1. The Chairperson of the fifty-sixth session of the Commission will make an introductory statement.
- 2. Welcoming remarks will also be made by the High Commissioner for Human Rights.

Item 2. Implementation of Commission decision 2000/109

Legislative authority

3. At its fifty-sixth session, the Commission decided, in decision 2000/109 of 26 April 2000, to approve and implement comprehensively and in its entirety the report of the inter-sessional open-ended working group on enhancing the effectiveness of the mechanisms of the Commission (E/CN.4/2000/112).

4. The attention of the Commission is drawn to paragraphs 33 and 34 of the above-mentioned report, which state the following:

"The cycle of meetings (the Commission session in spring; the United Nations General Assembly in autumn) is such that the Third Committee of the General Assembly is well placed to consider developments in the interim since the Commission session. Given the significant overlap both in agenda and in attendance between the Commission and the Third Committee, the Working Group considers that there is scope for a more dynamic sense of connection between the two. In particular, the Group recognizes the rationale for some form of enhanced preparation in Geneva so as to ensure that all delegations have relevant information available to them in their preparations for the Third Committee. "The Working Group therefore recommends that the Chairperson of the Commission should convene a one-day informal meeting of the Commission in late September each year specifically to facilitate exchange of information in advance of the General Assembly. The meeting, which would not have a formal outcome, would have an agenda comprising those issues which had been dealt with at the previous Commission session and which were also on the provisional agenda for the Third Committee. Each item would be focussed on briefly, with information from the secretariat on any developments since the Commission session, and an opportunity for comment by government representatives, including any indication of intentions for tabling resolutions in the Third Committee." Background information

5. In accordance with information provided by the Third Committee secretariat, all the General Assembly Committees will begin their work a week earlier this year, namely on 25 September. The Third Committee will begin consideration of the major human rights cluster on 11 October 2000 with the item on the promotion and protection of the rights of children. Consideration of other human rights

items would begin on Monday, 23 October 2000. It is proposed that the High Commissioner's dialogue take place on the afternoon of 24 October or the morning of 25 October, followed by the dialogues with the special rapporteurs.

6. The human rights items to be allocated to the Third Committee by the General Assembly this year are as follows:

112. Promotion and protection of the rights of children;

- 113. Programme of activities of the International Decade of the World's Indigenous People;
- 114. Elimination of racism and racial discrimination;
- 115. Right of peoples to self-determination;
- **116.** Human rights questions:
 - (a) Implementation of human rights instruments;
 - (b) Human rights questions, including alternative approaches for improving the effective enjoyment of human rights and fundamental freedoms;
 - (c) Human rights situations and reports of special rapporteurs and representatives;

(d) Report of the United Nations High Commissioner for Human Rights.

7. It is proposed that the secretariat make presentations of a primarily informative nature concerning the human rights items allocated by the General Assembly to the Third Committee this year. These presentations will provide highlights of significant developments since the fifty-sixth session of the Commission with respect to the human rights items to be considered by the Third Committee, and pertinent information with respect to the reports submitted by OHCHR to the Third Committee. They will be limited to 10 minutes per item (10 minutes per sub-item for item 116).

8. A general discussion will follow the presentation of each item by the secretariat (questions and answers).

Proposed organization of work

9. It is proposed that, following a presentation of each issue/item in the order of the human rights agenda items of the Third Committee, government representatives, representatives of United Nations departments, specialized agencies and intergovernmental organizations, if any, will be given the floor for a maximum of three minutes per intervention. Special Rapporteurs and representatives of the treaty bodies will be invited, if they so desire, to submit a maximum of one page providing the essence of any significant developments regarding their respective reports, which will be read out by the secretariat.

10. It is proposed that two segments of 20 minutes each be allocated to non-governmental organizations at the end of the morning and afternoon sessions for comments.

11. As a tentative time-table for the meeting, it is proposed that the discussion on items 112 to 116 (a) take place during the morning meeting, and on sub-items 116 (b), (c) and (d) during the afternoon meeting.

Item 3. Round-up of the meeting

12. Final remarks will be made by the Chairperson of the Commission on Human Rights and by the High Commissioner for Human Rights.
