Memorandum dated 31 August 2000 from the Secretary of the Fifth Committee to the Secretary of the Third Committee

I am writing to bring to your attention the following recommendations made by the Committee for Programme and Coordination during its thirty-ninth session, which were endorsed by the General Assembly in paragraph 2 of its resolution 54/236 of 23 December 1999, entitled "Programme planning".

"The Committee recommended that the specialized intergovernmental bodies, as well as the Economic and Social Council and the Main Committees of the General Assembly, should include, in their programme of work, an agenda item on programme planning for the review of the proposed medium-term plan and its revisions. The Committee also recommended that the Fifth Committee receive all relevant comments prior to its consideration of the proposed medium-term plan and its revisions" (A/54/16, part I, para. 55).

At its recently held fortieth session, the Committee for Programme and Coordination reiterated that recommendation, as follows:

"The Committee reiterated its recommendations that the relevant intergovernmental bodies, as well as the Economic and Social Council and the Main Committees of the General Assembly, should include in their programme of work an agenda item on programme planning for the review of the proposed medium-term plan and its revisions" (A/55/16, part II, para. 88).

The reports of the Committee for Programme and Coordination are contained in documents A/55/16 (part I) and Corr.1 and 2 and A/55/16 (part II). The proposed medium-term plan for the period 2002-2005 is contained in document A/55/6 (Programmes 1-25). A list of the programmes is attached hereto for your convenience.

In this connection, I should be grateful if you could convey this matter to the members of the Bureau of your Committee, with a view to transmitting to the Fifth Committee by **25 October 2000** the results of the deliberations of your Committee on the review of the relevant programmes of the proposed medium-term plan for the period 2002-2005.

For your information, the Fifth Committee is expected to begin its consideration of the item on programme planning on Tuesday, 31 October.
