

# **Appointment of members of the International Civil Service Commission**

# Note by the Secretary-General

- 1. As indicated in document A/55/107 of 28 June 2000, it will be necessary for the General Assembly, during its current session, to appoint five persons to fill vacancies that will occur in the membership of the International Civil Service Commission, beginning on 1 January 2001.
- 2. The members of the Commission whose terms of office expire on 31 December 2000 are:
  - Ms. Corazon Alma G. de Leon (Philippines)
  - Mr. Alexei L. Fedotov (Russian Federation)
  - Mr. Humayun Kabir (Bangladesh)
  - Mr. Ernest **Rusita** (Uganda)
  - Mr. El Hassane Zahid (Morocco)

Thus, the members to be appointed should come from the following regions:

Two members from the African States;

Two members from the Asian States;

One member from the Eastern European States.

- 3. The Member States have submitted the following candidatures:
  - (a) For the Group of African States (two vacancies):

Mr. Ernest Rusita (Uganda);

Mr. El Hassane **Zahid** (Morocco);

(b) From the Asian States (two vacancies):

Ms. Corazon Alma G. de Leon (Philippines);

Mr. Asda Jayanama (Thailand);

Mr. C. M. **Shafi Sami** (Bangladesh);

(c) From the Eastern European States (one vacancy):

Mr. Alexei L. Fedotov (Russian Federation).

- 4. The appointment of the members of the Commission is governed by the provisions of articles 3, 4 and 5 of its statute. Pursuant to those provisions, and in accordance with paragraphs 3 and 4 of section II of General Assembly resolution 43/226 of 21 December 1988, the Secretary-General has undertaken consultations with Member States, through the Chairmen of the various regional groups, with the executive heads of the other organizations, with staff representatives through the Federation of International Civil Servants' Associations and the Coordinating Committee for International Staff Unions and Associations of the United Nations system and with the Advisory Committee on Administrative and Budgetary Questions.
- 5. Regarding consultations with Member States, Mr. Alexei L. Fedotov has been endorsed by the Group of Eastern European States.
- 6. The Secretary-General thus submits to the Fifth Committee for its consideration the list of candidates nominated for membership in the International Civil Service Commission for a four-year term of office beginning 1 January 2001:

# Corazon Alma G. de Leon (Philippines)

Corazon Alma G. de Leon's 33-year career in the public service is a fine example of the merit-and-fitness principle at work.

A Career Executive Service Officer (CESO) with Rank I, she started out as a Community Welfare Supervisor in the Department of Social Welfare and Development (DSWD) in 1966. Twenty-seven years later, in September 1993, she became the DSWD Secretary, capping a steady career rise which saw her hold such positions as Social Welfare Specialist, Acting Bureau Assistant Director, Regional Director, Assistant Secretary and Under-Secretary.

Her stint with DSWD was cut short when President Fidel V. Ramos appointed her as Chairman of the Civil Service Commission, one of the independent constitutional commissions in the Philippine Government set-up. In that position, which incidentally made her the ex-officio Chairman of the Career Executive Service Board, Chairman de Leon finds herself responsible for the entire personnel administration system covering 1.3 million civilian government employees.

Her tenure as CSC Chairman has so far been marked by a continuing drive to instil professionalism at all levels and ranks of the public service, complemented by steady infusion of a much-welcome humanist dimension in personnel administration policy to ensure en energized bureaucracy.

Chairman de Leon's skills and expertise in the handling of people and organizations are widely recognized, here and abroad. Shortly after taking over the helm of CSC, she was elected as member to the prestigious International Civil Service Commission of the United Nations, enjoying a term of office until 2000. But she is not stranger to such honour, for even before, she had already headed official Philippine delegations to various international conferences on social work and social development, public administration, population, health and welfare issues, gender equality and disaster management.

A multidisciplinary foundation underlies the career of Chairman de Leon. She obtained a Bachelor of Arts degree in Social Work from the University of the Philippines. She continued with a grant from the Queen Isabella Foundation Scholarship, which enabled her to earn a Master's degree in the same field from the Catholic University of America in Washington, D.C. To supplement her social work studies, she enrolled under a USAID-NEDA grant, and successfully completed a Master's degree in Public Health at the University of Pittsburgh, Pennsylvania, United States. At present, she is working for her doctoral degree in Public Administration from the University of the Philippines.

Apart from her governmental involvement, she is also actively into various volunteer activities. Her more notable engagements include the chairmanship of the Membership Committee of the Girl Scouts of the Philippines and the Paranaque Development Foundation. She is also the President of the International Social Service Philippines Foundation, the Philippine Association of Technical Assistance Participants (PATAP) and a member of the Board of the World Association of Psychosocial Rehabilitation and the Board of Trustees of the Development Academy of the Philippines.

Chairman de Leon was recently awarded the Most Distinguished Alumna of the University of the Philippines for the year 2000.

# Asda Jayanama (Thailand)

Ambassador Asda Jayanama was appointed Permanent Representative of Thailand to the United Nations and presented his credentials to the Secretary-General on 14 February 1996. Upon his appointment, he served as Co-Vice-Chairman of the Open-Ended Working Group on the Question of Equitable Representation On and Increase in the Membership of the Security Council and Other Matters Related to the Security Council from 1996 to 1998, when he resigned. During 1996-1998, he was involved in the Working Group on Peacekeeping Operations of the Movement of Non-Aligned Countries when the Thai Mission in New York was Chairman. In January 1999, he was elected President of the United Nations Development Programme/United Nations Population Fund Executive Board. He also served as one of the Vice-Presidents (Thailand) of the fifty-fourth session of the United Nations General Assembly. He is a council Member of the Global Environment Facility, representing Constituency 7, to 15 September 2000. Elected on 25 February 2000, he is currently a member of the Bureau and Co-Chairman of the Preparatory Committee for the High-Level International Intergovernmental Event on Financing for Development.

Prior to his appointment as Permanent Representative to the United Nations, from 1993 to 1995, he was Director-General of the Department of International Organizations of the Thai Ministry of Foreign Affairs, where he was extensively involved with the administration of the Thai Foreign Ministry, including as an elected member of the Thai Foreign Ministry's Civil Service Committee. As Director-General of the Department of International Organizations, he was also the official Thai Permanent Representative to ESCAP.

Ambassador Jayanama started his diplomatic service in 1966 and has served as the Ambassador of Thailand to New Zealand (1990-1993), Singapore (1986-1990) and Viet Nam (1984-1986). He was also the deputy representative of Thailand to the United Nations Educational, Scientific and Cultural Organization (UNESCO) while stationed at the Royal Thai Embassy in Paris as Minister from 1981 to 1984. From 1976 to 1979, while posted at the Royal Thai Embassy in Vienna, he was the Alternate Representative of Thailand to the United Nations Industrial Development Organization (UNIDO) and the International Atomic Energy Agency (IAEA). He was also Rapporteur to the UNIDO Executive Board for 1978, and Chargé d'affaires to Austria in 1979. His first foreign posting was at the Royal Thai Embassy in Yangon from 1969 to 1973.

In between foreign assignments, Ambassador Jayanama served in the following positions at the Ministry of Foreign Affairs: Director of the South-East Asia Division, Political Department (1979-1981); Chief of the Africa and Arab World Division, Political Department (1979); Chief of the International Development Affairs Division of the International Organizations Department (1974-1976); and Chief of Section of the International Economics Division, Economics Department.

Ambassador Jayanama has received a number of Thai and foreign decorations in recognition of his career in the diplomatic service.

Ambassador Jayanama graduated from the University of California at Los Angeles with the degree of Bachelor of Arts in Economics in 1964 and a Master of Arts degree in International Economics in 1965.

## **Educational background**

He received his secondary education at the Lycée Sidi Lahcen Lyoussi in Séfrou and at the Lycée Moulay Smail in Méknes, where he obtained a baccalaureate in arts subjects (with English).

From 1970 to 1973 he attended the National School of Administration (ENA) in Rabat and was awarded a diploma in July 1973 (diplomatic section).

From September 1980 to December 1981 he took advanced-level courses at ENA in Rabat. During this period he completed a number of internships in Morocco and France, including one at the Ministry of Foreign Affairs of France and another at the Prefecture in Lille.

During the same period Mr. Zahid attended a management course in Morocco, obtaining a diploma in July 1981.

In December 1981, after successfully defending a dissertation on the subject of non-contentious administrative procedure, he obtained an advanced-level diploma from ENA.

He participated in a number of seminars, including one organized by ENA on further education and training, a seminar organized by the United Nations in April 1992 on United Nations budget methodology and a seminar on outer space organized by the Government of Canada in Montreal.

He was awarded a certificate of proficiency in English by the United Nations and a diploma in German language by the Goethe Institute in Rabat.

#### Professional experience and posts held

In July 1973 he began his diplomatic career in the Ministry of Foreign Affairs as Secretary for Foreign Affairs and assistant to the head of personnel.

In August 1974 he was posted to Germany (Düsseldorf) as Vice-Consul.

In September 1979 he returned to the Ministry of Foreign Affairs and was appointed head of the refugees and stateless persons unit in the Department of Consular and Social Affairs.

In January 1982 he was appointed Counsellor for Foreign Affairs and was assigned to the Department of Multilateral Economic Affairs. During this period he participated in meetings of the Economic Commission for Africa in Addis Ababa and in Tanger (Multinational Programming and Operational Centre (MULPOC)).

In September 1983 he was posted to the Permanent Mission of Morocco to the United Nations.

In 1993 he was promoted to the rank of Minister Plenipotentiary and in 1995 was appointed Deputy Permanent Representative.

Since being posted to New York he has represented Morocco in many United Nations bodies, committees and commissions and has assumed important responsibilities and duties as a member of their bureaux:
