 $\underline{\text{Having received}}$, in accordance with article 38 of the Provisional Rules for Claims Procedure ("the Rules"), the report and recommendations made by the panel of Commissioners concerning the tenth instalment of "E3" claims, covering 17 claims, 1/

- 1. <u>Approves</u> the recommendations made by the panel of Commissioners, and, accordingly,
- 2. <u>Decides</u>, pursuant to article 40 of the Rules, to approve the amounts of the recommended awards concerning the claims covered in the report. The aggregate amounts per country, based on the recommendations contained in table 14 of the report, are as follows:

- 4. Reaffirms that when funds become available payments shall be made in accordance with decision 73 (S/AC.26/Dec.73 (1999)) and decision 100 (S/AC.26/Dec.100 (2000)),
- 5. Recalls that when payments are made in accordance with decisions 73 and 100, and pursuant to the terms of decision 18 (S/AC.26/Dec.18 (1994)), the Governments shall distribute amounts received to the designated claimants in respect of approved awards within six months of receiving payment, and shall, not later than three months after the expiration of this time limit, provide information on such distribution,
- 6. <u>Requests</u> the Executive Secretary to provide a copy of the report to the Secretary-General, to the Government of the Republic of Iraq and to each respective Government.
