Developments in the Area of Environmental Management Standards*

Note by the Rapporteur on Quality

ISO/TC 207 held its 8th Plenary meeting in Stockholm from 11 to 18 June 2000. Member bodies from 60 countries participated in the meetings, as well as 11 liaison organizations.

The 8th Plenary meeting of ISO/TC 207 set the framework for upcoming committee activities. The Plenary concluded with 30 resolutions, which included support for the:

- Ongoing work/strategies of ISO/TC 207's six Subcommittees (SCs) and one Working Group (WG)
- Ongoing compatibility activities between ISO 14001 and ISO 9001
- Implementation of a process to establish a "Terminology Group" and disband SC6
- ❖ Issuance of a letter ballot to determine whether an NG0 Task Group will be established
- Strengthened Terms of References, and structure, of the Developing Countries Contact Group
- Ongoing work of the Climate Change Task Force
- Completed/ongoing work of the Spanish Translation Task Force.

Meeting participants declared the 8th Plenary meeting of ISO/TC 207 a resounding success. TC 207 accepted an invitation from the Malaysian Ambassador to Sweden to host the 9th Plenary meeting of ISO/TC 207 from June 3 to 10, 2001 in Kuala Lumpur. ISO/TC 207 also accepted an invitation from Colombia to host the 10th Plenary in Cartagena de Indias in 2002.

Here is the summary of main outcomes of the Subcommittees (SCs) and other meetings held in Stockholm.

Subcommittee 1 (SC1), Environmental Management Systems

Key discussion and outcomes included:

- Requested WG1 to initiate the revision process of ISO 14001:1996. The revision will be limited to consideration of issues related to compatibility of ISO 14001 with ISO 9001 and to clarification of the existing text. Any changes to the existing text should help understanding and implementation by users without resulting in additional requirements in ISO 14001. Any suggested changes will be considered against the criteria set by SC1 in the document SC1 N223 Annex B.
- Ensured that any existing/new issues in environmental management not dealt with within its current revision process are recorded for future analysis.
- ❖ Authorized WG2 to continue the revision process of ISO 14004:1996.
- Requested WG1 and WG2 to take into consideration relevant Joint Task Group (JTG) recommendations on compatibility during the revision of ISO 14001 and ISO 14004.
- Resolved to ensure that effective communication and liaison exists and is maintained with ISO/TC 207/SC4, to ensure appropriate consultation and communication during the revision of the ISO 14001 and ISO 14004 standards.
- ♦ Decided to accept the invitation to participate in ISO/CASCO/WG 20's revision of Guide 7 "Guidelines for the drafting of standards suitable to use for conformity assessment".

Subcommittee 2 (SC2), Environmental Auditing

Key discussion and outcomes included:

- ❖ ISO 14015 provides guidelines for the Environmental Assessment of Sites and Organizations (sometimes referred to as Environmental Due Diligence Assessments). ISO 14015 has been circulated for ballot as a Draft International Standard with a closing date of 1 October 2000.
- ❖ ISO 19011 provides guidelines on auditing of quality and environmental management systems. This document is being developed by a Joint Working Group (JWG) of TC 207/SC2 and TC 176/SC3 and will replace the current separate standards on quality and environmental auditing (ISO 10011 (guidelines for auditing quality system) and ISO 14010-14012).
- ❖ ISO 19011 has been circulated as the Second Committee Draft (CD). ISO/TC 207/SC2 resolved to take decisions on the further development of ISO 19011 after the next JWG meeting (September 2000) considers results of the CD2 ballot.

Subcommittee 3 (SC3), Environmental Labelling

Key discussion and outcomes included:

The first meeting of the new SC3/WG4 Type III Environmental declarations was the main focus of activity on environmental labels and declarations in Stockholm. The working group completed its first task, to review the comments submitted along with the ballots on TR 14025:2000 Environmental labels and declarations – Type III environmental declarations. The working group proposed a future work programme with the objective of further analyzing and resolving these issues. The SC endorsed this plan while making it clear that the time is not yet right to begin standardization of Type III environmental declarations.

- A proposal was put forward to encourage experts in LCA and in Type III environmental declarations to coordinate at the national level with a view to resolving the two substantive issues in relation to TR 14025 that had been raised in TC 207/SC5. These issues were the use of comparative assertions and the use of alternative methodologies in the application of Life Cycle Assessment (LCA) to Type III environmental declarations.
- With the publication of ISO 14021 on self-declared environmental claims and ISO 14024 on Type I environmental labelling, it was decided that the two working groups that developed these standards could be placed in abeyance until such time as they may again be needed.
- There was also considerable discussion of the need to facilitate implementation of the standards in the ISO 14020 series in developing countries, countries in transition to a market economy and generally throughout the world.

Subcommittee 4 (SC4), Environmental Performance Evaluation

As ISO 14031:1999 (Environmental performance evaluation - Guidelines) and ISO TR 14032:1999 (Examples of environmental performance evaluation) have been published, this SC addressed a series of administrative matters, including:

- Relationships/liaisons with other ISO/TC 207 subgroups. By resolution, the subcommittee agreed that its leaders would establish relations with the leaders of SC1 in order to obtain information that may be helpful for SC4 to determine whether it wishes to provide input on the revisions of ISO 14001 and ISO 14004. Furthermore, resolutions were passed to support the SC's review of SC5 draft document ISO 14048 (LCA data documentation format) and the ISO/TC 207 Climate Change Task Force's (CCTF) third draft interim report.
- The SC reviewed results of the very successful June 13, 2000 Environmental Performance Evaluation (EPE) workshop and agreed that the SC should organize another such workshop to be held in Kuala Lumpur at the June 2001 ISO/TC 207 meetings. This future workshop should feature EPE implementation examples from SMEs, Asian countries and organizations that have used Environmental Condition Indicators (ECIs).
- An open discussion was held on possible new or future work items for the SC, and Sweden indicated its interest in submitting a new work item proposal to either this SC or to ISO/TC 207 on the subject of internal and external communications.

Subcommittee 5 (SC5), Environmental Life Cycle Assessment

Key discussion and outcomes included:

- Resolved to collect ISO 14040 implementation data from member bodies.
- Circulation of the first working draft of ISO 14047 to SC5/WG4 for comments, with the second working draft going to SC5 for comments and vote prior to the 9th ISO/TC 207 meetings.
- Recommended change in title of ISO/CD 14048 to "Life Cycle Interpretation (LCI) Data Documentation Format". The second CD of ISO 14048 will be circulated to SC5 requesting positions on whether the documents should be a Technical Specification or an International Standard.

Subcommittee 6 (SC6), Terms and Definitions

Key discussion and outcomes included:

- SC6/Ad Hoc Group (AHG) -finalized entries to be included in the second edition of ISO 14050 Environmental Management-Vocabulary to be submitted to ISO CS for FDIS (Final Draft International Standard) ballot.
- SC6/AHG1 discussed terminology coordination issues related to cooperation with ISO/TC 176.
- Recommended that a new "Terminology Group", with committed participation from other ISO/TC 207 SCs and WGs, be established and SC6 eventually disbanded. Detailed guidelines regarding the Scope, Leadership, Membership and Operations of the proposed group were developed and presented to the Chair's Advisory Group.
- Recommended that work continues and be strengthened on the development of a "Multilingual Term Bank of Environmental Management".

Working Group 3 (WG3), Design For The Environment

ISO/TC 207/WG3 meetings focused on developing structure and content for the first draft of the ISO/TR 14064 (Integrating Environmental Aspects into Product Development). Participants agreed to circulate the first working draft to WG3 members for comments by the end of June 2000 and set their next meeting for October 11 to 13, 2000 in Toronto, Canada.
