- 20. **Mr. Nakkari** (Syrian Arab Republic) drew attention to a translation error in paragraph 8 of the Arabic version of the draft text and to the fact that paragraph 10 still appeared in brackets in that version.
- 21. **Ms. Buergo Rodríguez** (Cuba) said that the first word in paragraph 8 of the Spanish version of the draft text should be "*Nota*" rather than "*Toma*".
- 22. Her delegation wished to reiterate its concern that proper procedures had not been followed in submitting the Rapid Deployment Management Unit concept to the Fifth Committee. The concept should have first been reviewed by the Special Committee on Peacekeeping Operations. She also wished to draw attention to paragraph 9, which requested the Secretary-General to take into account the mandate of relevant committees before requesting any human or financial resources.
- 23. **The Chairman** said that the necessary editorial changes would be made to the Arabic and Spanish texts.

- 34. **Mr. Ramos** (Portugal), speaking on behalf of the European Union in explanation of position before the decision, said that, despite its strong reservations regarding paragraphs 1 and 2, his delegation would join the consensus because of the urgency of the task at hand. Paragraphs 1 and 2 were not reflected in any other resolutions or decisions of a similar nature. Indeed, operational considerations relating to peacekeeping and the deployment of military personnel should have no place in resolutions such as the one before the Committee. The Committee should avoid such action in future.

- 36. **Ms. Buergo Rodríguez** (Cuba), Vice-Chairman, introduced draft resolution A/C.5/54/L.86, entitled "Analysis of the organizational structure and the personnel and technical resources of the Non-Governmental Organizations Section of the United Nations Secretariat", which she had earlier submitted, following informal consultations.
- 37. Draft resolution A/C.5/54/L.86 was adopted.

Review of resource requirements for the High-Level International Intergovernmental Event for Financing for Development and the Third United Nations Conference on the Least Developed Countries

Draft resolution A/C.5/54/L.82

38. **Mr. Kwok** (Singapore), introducing draft resolution A/C.5/54/L.82, entitled "Review of resource requirements for the High-Level International Intergovernmental Event for Financing for Development and the Third United Nations Conference

on the Least Developed Countries", said that the word "and" after "trust fund" in paragraph 2 of Section A of the draft resolution should be deleted.

- 39. Draft resolution A/C.5/54/L.82, as orally amended, was adopted.
- 40. **Ms. Buergo Rodríguez** (Cuba) said that her delegation regretted that it had not been possible to find a formula to finance all the meetings desired. It was concerned at the situation where established budget procedures for new mandates were not being applied, thereby affecting the implementation and quality of those mandates.
- 41. **Mr. Fujii** (Japan) said that the Committee should look for the resources needed from the regular budget and voluntary contributions.

#### Millennium Summit

- 42. Mr. Halbwachs (Controller), in response to a request for information on the costs of the arrangements for the Millennium Summit, said that the assumptions on which General Assembly resolution 54/254 was based had been revised after further review. The Economic and Social Council Chamber would not be reconfigured for the event and no media tent would be provided. In order to accommodate delegations and the media, it had been decided to delay relocation of the archives until after the event. Voluntary contributions would cover the public information activities planned. Thus, the additional requirements for the Summit should not exceed \$1 million. Should it be decided not to provide coverage for the interactive round table, the cost would amount to approximately \$850,000.
- 43. **The Chairman** suggested that the Committee should take note of the information provided by the Controller.

Reformed Procedures for Determining Reimbursement to Member States for contingent-owned equipment

- 45. **Ms. Buergo Rodríguez** (Cuba), Vice-Chairman, introducing draft resolution A/C.5/54/L.92, entitled "Reformed Procedures for Determining Reimbursement to Member States for contingent-owned equipment", said that the informal consultations on the draft resolution had not resulted in a consensus. She therefore requested that further consideration of the matter be deferred until early in the main part of the fifty-fifth session of the General Assembly.
- 46. **Mr. Chandra** (India) said that it was his understanding that the matter would be discussed early enough in the fifty-fifth session to enable a decision to be taken before the Phase V Working Group completed its work.
- 47. **The Chairman** said that she took it that the Committee wished to defer consideration of the matter to the main part of the fifty-fifth session of the General Assembly.
- 48. It was so decided.

**Agenda item 124: Pattern of conferences** (*continued*) (A/C.5/54/L.83)

- 50. **Ms. Buergo Rodríguez** (Cuba), Vice-Chairman, reporting on the results of the informal consultations, said that, regrettably, no agreement had been reached on the letter from the Chairman of the Committee on Conferences to the Chairman of the Fifth Committee.
- 51. Mr. Odaga-Jalomayo (Uganda) said that his delegation was submitting the text of draft resolution

A/C.5/54/L.83 on behalf of Kenya, Uganda and the United Republic of Tanzania. In view of the 24-hour rule, it might not be possible to take action on the draft at the current meeting. He therefore proposed that the text should be submitted directly to the General Assembly for consideration by the Assembly in plenary meeting.

- 52. **Mr. Halbwachs** (Controller) said, with reference to the programme budget implications of paragraph 2 of the draft resolution, that paying the expenses of one representative of each Member State of the Committee would constitute an exception to the normal travel arrangements and violate the principles set forth in General Assembly resolution 1798 (XVII) of 1962. It would also involve an additional requirement of up to \$152,000.
- 53. Mr. Repasch (United States of America) said that, since the draft resolution had programme budget implications, it was his understanding that it required review by the Advisory Committee on Administrative and Budgetary Questions before it could be considered in plenary meeting.
- 54. **Mr. Halbwachs** (Controller) confirmed that, under rule 153 of the rules of procedure of the General Assembly, no resolution involving expenditure could be recommended by a committee for approval by the General Assembly unless it was accompanied by a statement of programme budget implications and a report from the Fifth Committee.
- 55. **The Chairman** said that, as it was not possible to submit the draft resolution directly to the General Assembly, she took it that the Committee wished to postpone its consideration to a later date, pending the issuance of a statement of programme budget implications and the related report of the Advisory Committee.
- 56. It was so decided.
- 57. **Mr. Nakkari** (Syrian Arab Republic) said that his delegation regretted that it had not been possible to adopt the draft resolution, as very little time remained before the session of the Committee on Conferences. It was disappointed that the committee had not complied with General Assembly resolution 54/248. His delegation hoped that it would receive the answers to the questions it had raised on that matter in the near future.

#### Other matters

58. **Mr. Medina** (Morocco) said that his delegation had objected to the selective manner in which information circular ST/IC/2000/33 concerning the 2000 competitive examination for Arabic Language Coordinator had been drafted, which would have resulted in discrimination against individuals without a mastery of English. His delegation had therefore submitted a draft resolution on the topic and had subsequently been informed that the Secretariat was in the process of issuing a revision of the requirements to include a working knowledge of either English or French. Morocco consequently withdrew its draft resolution.

## Closure of the second part of the resumed fiftyfourth session of the Fifth Committee of the General Assembly

59. After an exchange of courtesies in which **Mr. Ramos** (Portugal), speaking on behalf of the Western European and Other States group, and **Mr. Hassan** (Nigeria), speaking on behalf of the Group of 77 and China, participated, **the Chairman** declared the work of the Fifth Committee at the second part of the resumed fifty-fourth session of the General Assembly closed.
