

# **Macroeconomic policy questions**

# **Report of the Second Committee\***

Rapporteur: Mr. Ahmed Amaziane (Morocco)

1. At its 9th plenary meeting, on 11 September 2000, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-fifth session the item entitled:

"Macroeconomic policy questions:

- "(a) Trade and development;
- "(b) Commodities;
- "(c) External debt crisis and development;
- "(d) Science and technology for development;
- "(e) Financing of development, including net transfer of resources between developing and developed countries"

and to allocate it to the Second Committee.

2. The Second Committee considered the item at its 8th to 10th, 13th, 16th, 26th to 28th, 30th, 34th, 35th, 38th, 40th and 42nd meetings, on 6, 9, 12, 18, 26, 27 and 31 October, 15, 20 and 29 November and 1 and 8 December 2000.
