Questionnaire on blue markings

Note by the secretariat

1. At its thirty-fifth session, concerning the proposed amendment to Article 29.2 of the Vienna Convention on Road Signs and Signals (paragraph 41 ter of TRANS/WP.1/2000/20 on the use of blue markings to indicate a limitation on the duration of parking), the Working Party agreed with the recommendation of the Ad hoc Legal Experts Group that this issue had to be clarified and requested the representative of Poland who had written the proposal to develop a questionnaire for member countries on the use of blue markings.
2. The secretariat sent the questionnaire to member countries and received the following replies.
3. The 20 replies show that 8 countries use blue markings to indicate parking. Hungary is discussing the possible introduction of blue markings for parking.

3. Parking is subject to payment and duration of parking is limited. Managers of certain roads mark parking places with blue markings and traffic signs. Parking so marked is limited to 2 hours.

**Switzerland**

3. The so-called blue zone in our country is signaled by a sign and by blue markings on the ground. Without any further time limit shown on the sign, it means that vehicles are allowed to park there one hour if they arrive between 08.00 and 11.30 or between 13.30 and 18.00 on workdays. If they arrive between 11.30 and 13.30 they are allowed to stay until 14.30. If they arrive between 18.00 and 08.00 they are allowed to stay until 09.00. These special rules, as well as the correct setting of the time of arrival, are noted on the parking disk.  
Duration of parking is limited but parking is not subject to payment. All vehicles with dimensions close to the dimension of the parking space may be parked there.
