

# 1. Opening of the session

#### 4. Organizational arrangements for the preparatory process and the special session

#### Update on preparations

The report of the Secretary-General on the state of the preparations for the special session of the General Assembly in 2001 for follow-up to the World Summit for Children (A/55/429) was considered by the General Assembly at its 62nd and 63rd plenary meetings, on 15 November 2000. At its 69th plenary meeting, on 20 November 2001, the Assembly adopted resolution 55/26 on the preparations for the special session on children.

#### Update on reviews and appraisals

The substantive secretariat will make a presentation on the preliminary results of the implementation of the World Declaration on the Survival, Protection and Development of Children and Plan of Action for Implementing the World Declaration on the Survival, Protection and Development of Children in the 1990s. The presentation will draw upon materials prepared for various end-decade reviews. The Committee will be invited to make comments on these preliminary findings regarding trends and outcomes, which will later be incorporated in the report of the Secretary-General on the follow-up to the World Summit for Children.

To provide an in-depth understanding of certain key themes, two panel discussions will be organized on adolescent development and participation and on the girl child.

The Committee will be briefed on related forthcoming United Nations conferences and events.

#### Participation of non-governmental organizations in the special session

At its first substantive session, the Committee decided to defer to its second substantive session a decision on the arrangements for the participation of non-governmental organizations in the special session (see A/55/43 (part II),\* para. 25, decision 8). The Committee will be invited to consider this matter and to take action on it.

#### Participation of children and adolescents

The Committee will be invited to make comments on a note by the Chairperson of the Preparatory Committee concerning the participation of children and adolescents in the special session and its preparatory process.
