> Report of the Preparatory Committee for the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects

## I. Introduction

1. At its fifty-fourth session, the General Assembly adopted resolution 54/54 V of 15 December 1999, the operative part of which reads as follows:

"The General Assembly,

..

- "1. Decides to convene the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects in June/July 2001:
- "2. Also decides that the scope of the Conference shall be the illicit trade in small arms and light weapons in all its aspects;
- "3. Further decides to establish a preparatory committee open to participation by all States, which will hold no fewer than three sessions, the first session to be held in New York from 28 February to 3 March 2000;
- "4. Decides that the specialized agencies, other relevant intergovernmental organizations and relevant entities, having received a standing invitation to participate as observers in the sessions and in the work of the General

Assembly, shall participate, as observers, in the Preparatory Committee, and requests the Committee to take a decision on the modalities of attendance of non-governmental organizations at its sessions;

- "5. Requests the Preparatory Committee to decide, at its first session, on the date and venue of the Conference in 2001 as well as on the dates and venue of its subsequent sessions;
- "6. Stresses the need to ensure the widest possible and effective participation in the Conference in 2001;
- "7. Requests the Preparatory Committee to make recommendations to the Conference on all relevant matters, including the objective, a draft agenda, draft rules of procedure and draft final documents, which will include a programme of action, and to decide on background documents to be made available in advance;
- "8. Invites all Member States, in particular those that have not yet done so, in response to the note verbale of the Secretary-General dated 20 January 1999, to communicate to the Secretary-General their views on the agenda and other relevant questions relating to the Conference;

- "9. Requests the Secretary-General to transmit the replies of Member States relevant to paragraph 8 above to the Preparatory Committee and to render the Preparatory Committee and the Conference all necessary assistance, including the provision of essential background information, relevant documents and summary records;
- "10. *Endorses* the report of the Secretary-General on small arms, prepared with the assistance of the Group of Governmental Experts on Small Arms pursuant to General Assembly resolution 52/38 J [A/54/258], bearing in mind the views of Member States on the report;
- "11. Calls upon all Member States to implement the relevant recommendations contained in section IV of that report to the extent possible and where necessary in cooperation with appropriate international and regional organizations and/or through international and regional cooperation;
- "12. Requests the Secretary-General to seek the views of Member States on the report as well as on the implementation of the relevant recommendations contained therein;
- "13. Also requests the Secretary-General to implement the relevant recommendations contained in section IV of the report within available financial resources and with any other assistance provided by States in a position to do so and in cooperation with appropriate international and regional organizations where necessary;
- "14. Further requests the Secretary-General, in order to assist in preventing the illicit trafficking in and illicit circulation of small arms and light weapons:
- "(a) To carry out a study, within available financial resources and with any other assistance provided by Member States in a position to do so, and with the assistance of governmental experts appointed by him, on the basis of equitable geographical representation, while seeking the views of Member States, on the feasibility of restricting the manufacture and trade of such weapons to the manufacturers and dealers authorized by States, which will cover the brokering activities, particularly illicit activities,

- relating to small arms and light weapons, including transportation agents and financial transactions;
- "(b) To submit the study as one of the background documents for the Conference to be held in 2001;
- "15. Decides to include in the provisional agenda of its fifty-fifth session the item entitled 'Small arms'."
- 2. By its decision 55/415, entitled "Small arms", adopted on 20 November 2000, the General Assembly decided to convene the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects in New York, from 9 to 20 July 2001. It also decided to convene the third session of the Preparatory Committee for the Conference in New York, from 19 to 30 March 2001.
- Representatives from the following States participated in the second session of the Preparatory Committee: Algeria, Angola, Argentina, Armenia, Australia, Austria, Azerbaijan, Bahrain, Bangladesh, Barbados, Belarus, Belgium, Benin, Bolivia, Bosnia and Herzegovina, Brazil, Brunei Darussalam, Bulgaria, Burkina Faso, Cameroon, Canada, Central African Republic, Chile, China, Colombia, Congo, Costa Rica, Côte d'Ivoire, Croatia, Cuba, Cyprus, Czech Republic, Denmark, Egypt, Eritrea, Fiji, Finland, France, Gabon, Gambia, Germany, Ghana, Greece, Guatemala, Guinea, Guyana, Holy See, Hungary, India, Indonesia, Iraq, Jamaica, Japan, Ireland, Israel, Italy, Jordan. Kazakhstan, Kenya, Kyrgyzstan, Lao People's Democratic Republic, Lesotho, Liberia, Libyan Arab Jamahiriya, Liechtenstein, Lithuania, Malaysia, Mali, Malta, Marshall Islands, Mauritius, Mexico, Monaco, Mongolia, Morocco, Mozambique, Myanmar, Nauru, Nepal, Netherlands, New Zealand, Niger, Nigeria, Norway, Oman, Pakistan, Panama, Papua New Guinea, Paraguay, Peru, Philippines, Poland, Portugal, Qatar, Republic of Korea, Republic of Moldova, Romania, Russian Federation, Samoa, Saudi Arabia, Senegal, Sierra Leone, Singapore, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, Sweden, Switzerland, Syrian Arab Republic, Thailand, The former Yugoslav Republic of Macedonia, Togo, Tonga, Trinidad and Tobago, Tunisia, Turkey, Ukraine, United Kingdom of Great Britain and Northern Ireland, United States of America, Uruguay, Venezuela, Viet Nam, Yemen, Yugoslavia and Zambia.

4. The following specialized agencies, intergovernmental organizations and relevant entities participated as observers in the second session of the Preparatory Committee: the European Commission, the Permanent Observer Mission of the International Organization of la Francophonie, the Permanent Observer Mission of the Organization of African Unity, the International Committee of the Red Cross, the United Nations Children's Fund, the United Nations Development Programme, the World Health Organization and the World Bank.

## II. Organization of the Work of the **Preparatory Committee**

- Pursuant to the decision adopted at its first session (see A/CONF.192/PC.9, para. Preparatory Committee held its second session at United Nations Headquarters from 8 to 19 January 2001
- During its second session, the Committee held a total of 17 plenary meetings.
- At its 11th meeting, held on 8 January 2001, the Committee was informed that the Group of African States had endorsed the candidacy of Mr. Jean Du Preez of South Africa for the position of vicechairman.
- The Committee was also informed that, following the resignations of Mr. Filipe de Macedo Soares of Brazil and Mr. Juan Miguel Miranda of Peru from their positions as vice-chairmen, the Group of Latin American and Caribbean States had respectively endorsed Ms. Ana-Maria Sampaio Fernandes of Brazil and Mr. Raul Salazar Cosio of Peru to replace them.
- The Committee was also informed that, following the resignations of Mr. Pierre Charasse of France, Mr. Mario Duarte of Portugal, and Mr. Mark Gaillard of Canada from their positions as vice-chairmen, the Group of Western European and Other States had respectively endorsed Ms. Marie-France André of Belgium, Mr. Henrik Salander of Sweden, and Mr. Robert McDougall of Canada to replace them.
- 10. At the same meeting, the Committee elected the following officers:

- 11. At the same meeting, the Committee decided that the Secretary of the Preparatory Committee would assist the Chair in preparing the report and would submit it to the Committee.
- 12. Ms. Agnès Marcaillou, Senior Political Affairs Officer, Department for Disarmament Affairs, served as Secretary of the Preparatory Committee.
- 13. Also at its 11th meeting, the Committee considered the timetable submitted by the Chair for the week 8 to 12 January 2001, as contained in Informal Paper No. 1 of 8 January 2001, and decided to devote the first week of its work to general statements followed by a sequential consideration, in plenary meetings, of the Chairman's working paper entitled "Draft programme of action to prevent, combat and eradicate the illicit trade in small arms and light weapons in all its aspects", as contained in document A/CONF.192/PC/L.4.
- 14. At its 19th meeting, held on 15 January, the Committee considered the timetable submitted by the Chair for the week 15 to 19 January 2001, as contained in Informal Paper No. 2 of 15 January 2001, and adopted it as amended (Informal Paper No. 2/Rev.1 of 16 January).
- 15. At its 21st meeting, held on 16 January, the Chairman informed the Preparatory Committee that the Secretary-General of the United Nations had designated Mr. Joao Honwana, Chief, Conventional Arms Branch, Department for Disarmament Affairs, as Secretary-General of the Conference, and Mr. Mohammed Sattar, Senior Political Affairs Officer, Department of General Assembly Affairs and Conference Services, as Deputy Secretary-General of the Conference.
- 16. At its 20th meeting, held on 15 January, the Preparatory Committee decided to hold an informal meeting on 18 January to listen to the views of nongovernmental organizations. It was agreed that the decision of the Preparatory Committee was taken

without prejudice to its consideration of the draft decision on "modalities of attendance of non-governmental organizations at the sessions of the Preparatory Committee". It was also agreed that this decision would not constitute any precedent for the future.

- 17. - 22. A list of delegations participating in the second session of the Preparatory Committee for the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects is contained in document A/CONF.192/PC/28.
- 23. Pursuant to the decision of the General Assembly of 15 December 1999 that summary records be provided for only those meetings at which decisions would be taken, summary records were provided for five meetings, i.e., the 11th, 19th, 20th, 25th and 26th meetings.

## III. Decisions of the Preparatory Committee

- 24. At its 20th meeting, held on 15 January 2001, the Preparatory Committee decided to recommend that draft rule 33 of the draft rules of procedure 33 on "decision making", contained in document A/CONF.192/PC/L.8, be included in the draft rules of procedure for the Conference (A/CONF.192/PC/L.5).
- 25. At its 26th meeting, the Committee decided to recommend to the Conference the draft provisional agenda for the Conference, as contained in A/CONF.192/PC/L.2/Rev.1.
- 26. At its 28th meeting, the Committee decided to continue its consideration of the draft rules of procedure for the Conference, as contained in A/CONF.192/PC/L.5, at its third session.
- 27. At the same meeting, the Committee decided to continue its consideration of the modalities of attendance of non-governmental organizations at the sessions of the Preparatory Committee at its third session.
- 28. At the same meeting, the Committee also decided to continue its consideration of the draft objective of the Conference at its third session.
- 29. At the same meeting, the Committee also decided to continue its consideration of the decision on background documents to be made available in advance.

- 30. At the same meeting, the Committee also decided to continue its consideration of the draft final documents, including a programme of action, at its third session.
- 31. The Preparatory Committee concluded its second session on 19 January 2001.
