### **Annotations**

#### **1. Adoption of the agenda and other organizational matters**

The provisional agenda for the second session of the Preparatory Committee for the High-level International Intergovernmental Event on Financing for Development has been drawn up on the basis of General Assembly resolution 54/196 of 22 December 1999; the draft resolution entitled "Further preparations for the substantive preparatory process and the high-level international intergovernmental event on financing for development" recommended by the Committee on 27 November 2000 for adoption by the Assembly;<sup>1</sup> and Committee decision 1/1 of 2 June 2000.<sup>2</sup> The proposed organization of work is contained in the annex.



## **2. Review of the inputs to the substantive preparatory process and the High-level International Intergovernmental Event on Financing for Development**

In its decision 1/1 of 2 June 2000,<sup>2</sup> the Committee adopted, based on paragraph 3 of General Assembly resolution 54/196 of 22 December 1999, the text contained in the annex to that decision as a substantive preliminary agenda for the financing for development process, on the understanding that this preliminary agenda is of indicative nature and will evolve during the substantive process ahead of the final event, through, inter alia, inputs from Member States, regional intergovernmental consultations and all relevant stakeholders.

As one of the important inputs to the substantive preparatory process and the High-level Event, the Committee will have before it for review the report of the Secretary-General, divided into the following six chapters, which correspond to the six main headings of the above-mentioned agenda.

- I. Mobilizing domestic financial resources
- II. Mobilizing international resources for development: foreign direct investment and other private flows
- III. Trade
- IV. Increasing international financial cooperation for development through, inter alia, official development assistance
- V. Debt
- VI. Addressing systemic issues: enhancing the coherence and consistency of the international monetary, financial and trading systems in support of development

Headings I to VI have been scheduled for separate discussions in the proposed organization of work (see annex).

As further input to the substantive preparatory process and the High-level Event, the Committee will have before it the reports of the five regional consultations held by the regional commissions in 2000.

The Committee will also have before it for review summaries of panel presentations and discussion at the hearings with civil society and the business community held in November and December 2000.
