### STATE OF PREPARATION OF DOCUMENTATION FOR THE FORTY-THIRD SESSION OF THE GENERAL ASSEMBLY

#### Note by the Secretary-General

1. In paragraph 3 of its resolution 39/68 D of 13 December 1984, the General Assembly requested the Secretary-General to circulate eight weeks before the opening of the session of each United Nations organ a report on the state of preparation at that time of documents required for the session and to identify the Secretariat unit responsible for any delay.
2. The present report gives the state of preparation as at 22 July 1988, i.e., eight weeks before the opening of the forty-third session of the General Assembly, of all documents required for the session. The agenda items are those of the provisional agenda (A/43/150). Estimated dates of submission of documents to the Division of General Assembly Affairs are those provided by the department or office responsible for the preparation of the document. Explanations for delay will be provided by the responsible offices.
