### **Draft programme budget for the biennium 2002-2003 for the Division for Sustainable Development, Department of Economic and Social Affairs**

#### **Note by the Secretariat**

1. The draft programme of work in the field of sustainable development for the biennium 2002-2003, which is contained in the annex, is submitted for the consideration of the Commission on Sustainable Development in compliance with the rules and regulations governing programme planning, the programme aspects of the budget, the monitoring of implementation and the methods of evaluation. In section I, paragraph 7, of its resolution 52/220, the General Assembly stressed the role of the relevant intergovernmental bodies in the consideration of the narrative of the proposed programme budget, as well as the necessity for a timely presentation of their recommendations on the budget.
2. The draft programme of work has been formulated within the framework of subprogramme 4 (Sustainable development) of programme 7 (Economic and social affairs) of the medium-term plan for the period 2002-2005.
3. The Commission is invited to comment and make recommendations, as appropriate, on the draft programme of work. These comments and recommendations will be taken into account, as appropriate, by the Secretary-General in finalizing his proposed programme budget for the biennium 2002-2003 which will be reviewed by the Committee for Programme and Coordination, the Advisory Committee on Administrative and Budgetary Questions, and the General Assembly at its fifty-sixth session.

#### **Programme 7 Economic and social affairs**

##### **Subprogramme 4 Sustainable development**

1. The subprogramme will be implemented by the Division for Sustainable Development.
2. The draft programme of work has been formulated within the framework of subprogramme 4 (Sustainable development) of programme 7 (Economic and social affairs) of the medium-term plan for the period 2002-2005.

##### **Objectives**

To ensure the effective and coordinated implementation of Agenda 21 and other commitments made during the United Nations Conference on Environment and Development, including the outcome of the Global Conference on the Sustainable Development of Small Island Developing States, the outcome of the twenty-second special session of the General Assembly to review the implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, the Programme for the Further Implementation of Agenda 21 adopted by the General Assembly at its nineteenth special session, as well as decisions of the Commission on Sustainable Development; to ensure implementation of the resolutions and decisions adopted by the Economic and Social Council on the recommendation of bodies responsible for energy and natural resources.

cleaner technologies strategies, environmental management accounting, integrated water resources management and energy for sustainable development

Provision of technical services to Member States under country, regional and interregional technical cooperation projects in the area of sustainable development supported from all sources of funding
