## Status of documentation

### Note by the Secretariat

1. In accordance with Economic and Social Council resolution 2008 (LX), annex, paragraph 8, the forty-first session of the Committee for Programme and Coordination will be held at Headquarters from 11 June to 6 July 2001.
2. In its resolution 1988/77 on its revitalization, the Council reiterated that the Secretariat should circulate relevant documentation in all working languages six weeks before the opening of sessions of the Council and its subsidiary organs.
3. In its resolutions 53/208, 54/490 and 55/702, the General Assembly (a) reiterated its request to the Secretary-General to ensure that documentation is available in accordance with the six-week rule for the distribution of documents simultaneously in the six official languages of the General Assembly; (b) reaffirmed its decision that if a report is issued late, the reason for the delay should be indicated when the report is introduced; and (c) also decided that if a report is submitted late to conference services the reasons for this should be included in a footnote to the document.
4. In the same resolutions, the General Assembly reiterated its request that the Secretary-General direct all departments to include, where appropriate, the following elements in reports originating in the Secretariat:
  - (a) A summary;
  - (b) Consolidated conclusions, recommendations and other proposed actions;
  - (c) Relevant background information.

5. Also in the same resolutions, the General Assembly reiterated that all documents submitted to legislative organs by the Secretariat and expert bodies for consideration and action should mark conclusions and recommendations in bold print.

6. Accordingly, the documentation for the forty-first session of the Committee should be circulated by 6 April 2001; the documents to be issued for the forty-first session are listed in the annex.
