Report of the Preparatory Committee for the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects

I. Introduction

1. At its fifty-fourth session, the General Assembly adopted resolution 54/54 V of 15 December 1999, the operative part of which reads as follows:

"The General Assembly,

- "1. Decides to convene the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects in June/July 2001:
- "2. Also decides that the scope of the Conference shall be the illicit trade in small arms and light weapons in all its aspects;
- "3. Further decides to establish a preparatory committee open to participation by all States, which will hold no fewer than three sessions, the first session to be held in New York from 28 February to 3 March 2000;
- "4. Decides that the specialized agencies, other relevant intergovernmental organizations and relevant entities, having received a standing invitation to participate as observers in the sessions and in the work of the General

Assembly, shall participate, as observers, in the Preparatory Committee, and requests the Committee to take a decision on the modalities of attendance of non-governmental organizations at its sessions;

- "5. Requests the Preparatory Committee to decide, at its first session, on the date and venue of the Conference in 2001 as well as on the dates and venue of its subsequent sessions;
- "6. Stresses the need to ensure the widest possible and effective participation in the Conference in 2001;
- "7. Requests the Preparatory Committee to make recommendations to the Conference on all relevant matters, including the objective, a draft agenda, draft rules of procedure and draft final documents, which will include a programme of action, and to decide on background documents to be made available in advance;
- "8. Invites all Member States, in particular those that have not yet done so, in response to the note verbale of the Secretary-General dated 20 January 1999, to communicate to the Secretary-General their views on the agenda and other relevant questions relating to the Conference;

- "9. Requests the Secretary-General to transmit the replies of Member States relevant to paragraph 8 above to the Preparatory Committee and to render the Preparatory Committee and the Conference all necessary assistance, including the provision of essential background information, relevant documents and summary records;
- "10. *Endorses* the report of the Secretary-General on small arms (A/54/258), prepared with the assistance of the Group of Governmental Experts on Small Arms pursuant to General Assembly resolution 52/38 J, bearing in mind the views of Member States on the report;
- "11. Calls upon all Member States to implement the relevant recommendations contained in section IV of that report to the extent possible and where necessary in cooperation with appropriate international and regional organizations and/or through international and regional cooperation;
- "12. Requests the Secretary-General to seek the views of Member States on the report as well as on the implementation of the relevant recommendations contained therein;
- "13. Also requests the Secretary-General to implement the relevant recommendations contained in section IV of the report within available financial resources and with any other assistance provided by the States in a position to do so and in cooperation with appropriate international and regional organizations where necessary;
- "14. Further requests the Secretary-General, in order to assist in preventing the illicit trafficking in and illicit circulation of small arms and light weapons:
- "(a) To carry out a study, within available financial resources and with any other assistance provided by Member States in a position to do so, and with the assistance of governmental experts appointed by him, on the basis of equitable geographical representation, while seeking the views of Member States, on the feasibility of restricting the manufacture and trade of such weapons to the manufacturers and dealers authorized by States, which will cover the brokering activities, particularly illicit activities,

- relating to small arms and light weapons, including transportation agents and financial transactions:
- "(b) To submit the study as one of the background documents for the Conference to be held in 2001;
- "15. *Decides* to include in the provisional agenda of its fifty-fifth session the item entitled 'Small arms'."
- 2. By its decision 55/415, entitled "Small arms", adopted on 20 November 2000, the General Assembly decided to convene the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects in New York, from 9 to 20 July 2001. It also decided to convene the third session of the Preparatory Committee for the Conference in New York, from 19 to 30 March 2001.

- Ms. Agnès Marcaillou, Senior Political Affairs Officer, Department for Disarmament Affairs, served as Secretary of the Preparatory Committee. As in the previous two sessions, the Secretary of the Preparatory Committee acted as Rapporteur.
- At its 28th meeting, on 19 March 2001, the Committee considered the timetable submitted by the Chair for the week of 19-23 March 2001, as contained in Informal Paper No. 1 of 19 March 2001. At the 36th meeting, on 26 March, the Committee considered the timetable submitted by the Chair for the week of 26-30 March 2001, as contained in Informal Paper No. 4 of 26 March 2001. The Committee adopted the two working timetables and decided to focus its work on the consideration of the Chairman's working paper entitled "Draft Programme of Action to Prevent." Combat and Eradicate the Illicit Trade in Small Arms Light Weapons in All Its Aspects" (A/CONF.192/PC/L.4/Rev.1). During plenary meetings, delegations made general statements and presented proposals on the Chairman's working paper. The Committee considered the working paper paragraph by paragraph in closed meetings. Amendments and additional proposals to the working paper were also considered.
- 10. The Preparatory Committee also agreed that the Chairman's working paper would be the basis for its substantive consideration of the draft Programme of Action.
- 11. At the 28th meeting, on 19 March, at the request of the Preparatory Committee, the representatives of the United Nations Centre for International Crime Prevention, Vienna, the Organization for Security and Cooperation in Europe (OSCE) and the Southern African Development Community (SADC) made statements respectively on the recent conclusion of the Protocol against the Illicit Manufacturing of and Trafficking in Firearms, Their Parts and Components and Ammunition, supplementing the United Nations

Convention against Transnational Organized Crime, the OSCE Document on Small Arms and Light Weapons, and the Southern African Development Community Declaration Concerning Firearms, Ammunition and Other Related Material.

- 12. At the same meeting, the Chairperson of the Group of Experts established pursuant to General Assembly resolution 54/54 V, Ms. Peggy Mason of Canada, presented the report of the Group (A/CONF.192/PC/33).
- 13. - 20. A number of documents were made available at the third session of the Preparatory Committee. The list of documents is contained in Information Paper No. 1 of 28 March 2001.
- 21. The list of delegations participating in the third session of the Preparatory Committee is contained in document A/CONF.192/PC/36.
- 22. Pursuant to the decision of the General Assembly of 15 December 1999 that summary records would be provided for only those meetings at which decisions were taken, summary records were provided for three meetings: the 33rd, 37th and 38th meetings.

III. Decisions and recommendations of the Preparatory Committee

A. Decisions

- 23. At the 33rd meeting, on 21 March 2001, in accordance with paragraph 4 of General Assembly resolution 54/54 V, the Preparatory Committee adopted a decision on modalities of attendance of nongovernmental organizations at its session and at the Conference (A/CONF.192/PC/L.7/Rev.2). Before the adoption of the decision, the Chairman stated, for the record, that it was the Committee's understanding that, once non-governmental organizations enjoving consultative status with the Economic and Social Council in accordance with the provisions of Council resolution 1996/31 of 25 July 1996 have informed the Chairman of the Preparatory Committee of their interest in participating in the Committee, they would have a right to participate in its session without being subjected to a second screening. In addition, the Chairman also stated that it was the Committee's understanding that the language contained in the decision would apply mutatis mutandis to the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects and that the language would be reflected in draft rule 64 of the draft rules of procedure of the Conference.
- 24. In accordance with paragraph 7 of the resolution, 54/54 V, the Preparatory Committee also decided that the Secretary-General's study carried out with the assistance of a group of governmental experts established pursuant to paragraph 14 of the resolution (A/CONF.192/PC/33) should be made available in advance. The Committee furthermore decided that those documents and papers made available to it, throughout the preparatory process, including the reports of its first, second and third sessions (A/CONF.192/PC/9, A/CONF.192/PC/30 and A/CONF.192/PC/50), would constitute background documents for the Conference.

B. Recommendations

25. At the 38th meeting on 30 March 2001, the Preparatory Committee adopted a recommendation proposed by Brazil, Mali, the Netherlands and the United Kingdom of Great Britain and Northern Ireland

(A/CONF.192/PC/57). The recommendation reads as follows:

"The Preparatory Committee for the United Nations Conference on the Illicit Trade in Small Arms and Light Weapons in All Its Aspects, which will be held at United Nations Headquarters from 9 to 20 July 2001,

- 1. Recommends that the first day of the Conference be proclaimed 'Small Arms Destruction Day';
- 2. Calls upon all States to organize, on a voluntary basis and, where possible, together with non-governmental organizations and civil society, public events of destruction of small arms and light weapons on 'Small Arms Destruction Day', and to ensure the widest possible dissemination of information about the events, including through national and international media;
- 3. Requests the Secretary-General of the United Nations to communicate this recommendation to all States and other participants in the meetings of the Preparatory Committee, including non-governmental organizations."
- 26. In accordance with paragraph 7 of General Assembly resolution 54/54 V, at the 38th meeting, the Committee recommended to the Conference the objective of the Conference, as contained in document A/CONF. 192/PC/L.3, for further consideration.
- 27. In accordance with the same paragraph, the Committee recommended to the Conference the draft agenda of the Conference, as adopted by the Committee at its second session (A/CONF.192/PC/L.2/Rev.2).
- 28. Also at the 38th meeting, the Committee recommended to the Conference that draft rule 64 on the modalities of attendance of non-governmental organizations at the Conference should be incorporated in the draft rules of procedure of the Conference (A/CONF.192/PC/L.5).
- 29. In accordance with the same paragraph, also at the 38th meeting, the Preparatory Committee recommended to the Conference the draft rules of procedure of the Conference (A/CONF. 192/PC/L.5), as amended by the insertion of draft rule 33 on decision-making, adopted by the Committee at its

second session (A/CONF.192/PC/L.8), and of draft rule 64 (A/CONF.192/PC/L.10).

- 30. Moreover, at its 38th meeting, the Preparatory Committee recommended that the Chairman's working paper entitled "Draft Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects", (A/CONF.192/PC/L.4/Rev.1), should be forwarded for further consideration at the Conference. The Committee also welcomed the intention of the Chairman to produce, under his own authority, an informal information sheet on the status of the discussions at the end of the third session of the Preparatory Committee.
- 31. At the same meeting, the Committee also recommended that the Conference should be held at the ministerial level (A/CONF.192/PC/L9).
- 32. At the same meeting, the Preparatory Committee recommended that the duration of each statement made during the general debate of the Conference should be limited to seven minutes.
- 33. The Preparatory Committee concluded its third session on 30 March 2001.
